

**DETERMINATION UNDER REGULATION 199A(1) OF THE ROAD TRAFFIC REGULATIONS,
1990, REGARDING A PERSONALISED REGISTRATION NUMBER SYSTEM FOR THE

- (a) a combination of a maximum of six letters and figures; or
- (b) a maximum of six letters; or
- (c) a maximum of six figures;

followed by a hyphen, followed by the letters WP.

**AMENDMENT OF GOVERNMENT NOTICE NO. R. 1579 OF 28 NOVEMBER 1997:
DETERMINATION UNDER REGULATION 199(2) OF THE ROAD TRAFFIC REGULATIONS
REGARDING A REGISTRATION PLATE FOR THE FREE STATE PROVINCE**

I, Abdulah Mohamed Omar, Minister of Transport, acting under regulation 199(2) of the Road Traffic Regulations, hereby amend Government Notice No. R. 1579 of 28 November 1997—

- (a) by the replacement of paragraph (b) with the following paragraph:
- “(b) subject to paragraph (e), a registration plate displaying a registration number or motor trade number issued by a registering authority in the Free State Province on or after 1 December 1997, shall display black letters and figures on a white retro-reflective surface;” and
- (b) by the addition after paragraph (d) of the following paragraph:
- “(e) a registration plate displaying a registration number or motor trade number issued by a registering authority in the Free State Province on or after 1 September 1999, shall display dark red letters and figures on a white retro-reflective surface, if that registration plate is displayed on a motor vehicle owned by the Provincial Government of the Free State Province: Provided that a registration plate displaying a registration number or motor trade number issued by a registering authority in the Free State Province on or after 1 August 1999 up and until 31 August 1999, displaying dark red letters and figures on a white retro-reflective surface, shall not be invalid by reason only of the fact that the registration number or motor trade number concerned was issued before 1 September 1999.”

“(b) behoudens paragraaf (e), vertoon 'n registrasieplaat wat 'n registrasienommer of motorhandelnommer vertoon wat uitgereik is deur 'n registrasie-owerheid in die Provinsie Vrystaat op of na 1 Desember 1997, swart letters en syfers op 'n wit trukaatsoppervlak;” en

(b) deur die volgende paragraaf na paragraaf (d) in te voeg:

“(e) 'n registrasieplaat wat 'n registrasienommer of motorhandelnommer vertoon wat uitgereik is deur 'n registrasie-owerheid in die Provinsie Vrystaat op of na 1 September 1999, donker rooi letters en syfers op 'n wit trukaatsoppervlak moet vertoon indien daardie registrasieplaat vertoon word op 'n motorvoertuig wat die eiendom is van die Provinsiale Regering van die Provinsie Vrystaat: Met dien verstande dat 'n registrasieplaat wat 'n registrasienommer of motorhandelnommer vertoon wat uitgereik is deur 'n registrasie-owerheid in die Provinsie Vrystaat op of na 1 Augustus 1999 tot en met 31 Augustus 1999, wat donker rooi letter en syfers op 'n wit trukaatsoppervlak vertoon, nie ongeldig is, slegs weens die feit dat die betrokke registrasienommer of motorhandelnommer uitgereik is voor 1 September 1999 nie;”.

ROAD TRAFFIC ACT, 1989 (ACT 29 OF 1989)**DETERMINATION UNDER REGULATION 199A(4) OF THE ROAD TRAFFIC REGULATIONS, 1990, REGARDING PERSONALISED REGISTRATION PLATE FOR THE NORTHERN CAPE PROVINCE**

I, Abdulah Mohamed Omar, Minister of Transport, acting under regulation 199A(4) of the Road Traffic Regulations, hereby determine that a registration plate displaying a personalised registration number issued by a registering authority in the Northern Cape Province on or after 1 September 1999, shall display the personalised registration number, followed by the logo as prescribed in the Schedule hereto, followed by the letters 'NC', on a white retro-reflective surface, and the letters and figures shall be—

- (a) subject to paragraph (c), in the colour mid-green if the personalised registration number consists of three figures, followed by three letters, followed by the letters "NC";
- (b) subject to paragraph (c), in the colour black in the case of a personalised registration number other than that mentioned in paragraph (a);
- (c) in the colour dark blue if the personalised registration number is displayed on a motor vehicle used for the conveyance of persons for reward.



- (a) a Gemsbok in the colour mustard 125C, and the legs, face and belly in the colour brown 1545C; and
- (b) ground and grass in the colour mustard 125C;



**AMENDMENT OF GOVERNMENT NOTICE NO. R. 868 OF 30 JUNE 1998:
DETERMINATION UNDER REGULATION 199(2) OF THE ROAD TRAFFIC
REGULATIONS, 1990, REGARDING REGISTRATION PLATE FOR THE NORTHERN
CAPE PROVINCE**

I, Abdulah Mohamed Omar, Minister of Transport, acting under regulation 199(2) of the Road Traffic Regulations, 1990 hereby amends Government Notice No. R. 868 of 30 June 1998 by the replacement of paragraph (a) with the following paragraph, so as to provide for the registration plate for motor vehicles used for the conveyance of persons for reward:

- "(a) a registration plate displaying a registration number or a motor trade number issued by a registering authority in the Northern Cape Province on or after the date of publication of this notice, shall display mid-green letters and figures of the German letter type referred to in paragraph 4.1.3.4 of Part II of standard specification SABS 1116 "Retro-reflective Registration Plates for Motor vehicles", and a landscape as prescribed in the Schedule hereto, on a white retro-reflective surface: Provided that where a registration number or a motor trade number, issued on or after 1 September 1999 by a registering authority in the Northern Cape Province, is displayed on a registration plate which is displayed on a motor vehicle used for the conveyance of persons for reward, the letters and figures displayed on such plate shall be dark blue;"
