REMUNERATION OF PUBLIC OFFICE BEARERS ACT, 1998 (ACT NO. 20 OF 1998)

DETERMINATION OF UPPER LIMIT OF SALARIES AND ALLOWANCES OF MEMBERS OF MUNICIPAL COUNCILS

Under the powers vested in me by section 7(1) of the Remuneration of Public Office Bearers Act, 1998 (Act No. 20 of 1998), and after consultation with the member of the Executive Council responsible for local government in each province, I, Fholisani Sydney Mufamadi, Minister for Provincial and Local Government, hereby amend Government Notice No. R.903 of 19 July 1999, as set out in the Schedule.

SCHEDULE

Definition

1. In this Schedule "Notice" means Government Notice No. R.903 of 19 July 1999.

Amendment of item 7 of the Notice

2. Item 7 is hereby amended by the insertion of the following proviso after paragraph (a):

"Provided that a member of a municipal council that does not so reside and is in receipt of a travel allowance on 30 June 1999, retains such allowance, on condition that it may not be increased."

Amendment of item 8 of the Notice

3. Item 8 is hereby amended by the substitution for paragraph (a) of the following paragraph:

"(a) Where the salaries and allowances which on 30 June 1999 are applicable to a particular position occupied by a member of a municipal council exceeds the salaries and allowances determined by this Notice for such post, any member of a municipal council occupying such position retains such higher level of payment, but on condition that no further upward adjustment be made in respect of such level of payment until the upper limits determined in terms of section 7 of the Remuneration of Public Office-bearers Act, 1998, equal such present higher levels, whereafter further adjustments will again apply to the position in question."

Kragtens die bevoegdehede my verleen by artikel 7(1) van die Wet op die Besoldiging van Openbare Ampsbekleërs, 1998 (Wet No. 20 of 1998), en na oorlegpleging met die Lid van die Uitvoerende Raad verantwoordelik vir plaaslike regering in elke provinsie, wysig ek, Fholisani Sydney Mufamadi, Minister vir Provinsiale en Plaaslike Regering, hiermee Goewermentskennisgewing No. R.903 van 19 Julie 1999, soos in die Bylae uiteengesit.

Omskrywing

1. In hierdie Bylae, beteken "Kennisgewing" Goewermentskennisgewing No. R.903 van 19 Julie 1999.

Wysiging van item 7 van die Kennisgewing

2. Item 7 word hierby gewysig deur die invoeging van die volgende voorbehoudsbepaling na paragraaf (a).

"Met dien verstande dat 'n lid van 'n munisipale raad wat nie so woonagtig is nie en op 30 Junie 1999 in ontvangs van 'n reistoelae is, sodanige toelae behou, op voorwaarde dat dit nie verhoog word nie."

Wysiging van item 8 van die Kennisgewing

3. Item 8 word hierby gewysig deur die vervanging van paragraaf (a) met die volgende paragraaf te vervang:

"(a) Waar die salaris en toelae soos op 30 Junie 1999 van toepassing is op 'n bepaalde posisie wat deur 'n lid van 'n munisipale raad bekleë word die salaris en toelae oorskry wat deur hierdie Kennisgewing vir sodanige pos bepaal is, behou enige lid van 'n munisipale raad wat so 'n posisie bekleë sodanige hoër vlak van besoldiging, maar op voorwaarde dat geen verdere opwaartse aanpassings ten opsigte van sodanige vlak van besoldiging gemaak word nie totdat die boonste perke bepaal ingevolge artikel 7 van die Wet op die Besoldiging van Openbare Ampsbekleërs, 1998, gelyk is aan sodanige huidige hoër vlakke, waarna verdere aanpassings weer van toepassing sal wees ten opsigte van die betrokke posisie."
