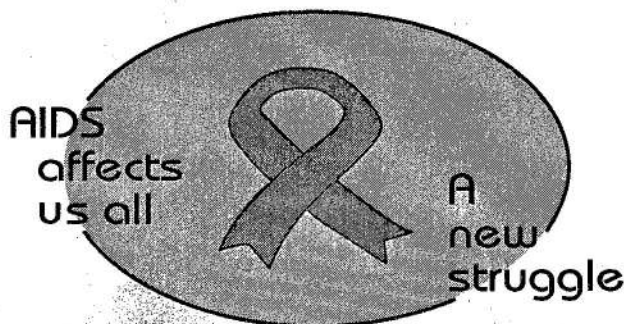

AMENDMENT OF REGULATIONS UNDER THE LONG-TERM INSURANCE ACT, 1998 (ACT NO. 52 OF 1998)

The Minister of Finance has under section 72, of the Long-term Insurance Act, 1998 (Act No 52 of 1998), read with section 49 of the Long-term Insurance Act, 1998, made the regulations in the Schedule.

SCHEDULE

Definition

1. In these regulations "the Regulations" means the regulations published under Government Notice No R 1492 of 27 November 1998.
