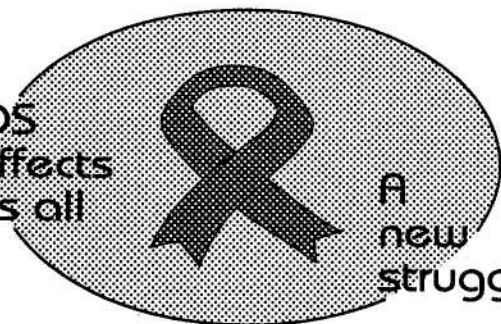

AMENDMENT OF LOCAL GOVERNMENT

SCHEDULE

Definition

1. In this Schedule the "Regulations" means the Local Government By-Election Regulations, 1997, published in Government Notice No. R.1730 of 19 December 1997.

Amendment of regulation 2 of the Regulations

2. Regulation 2 is hereby amended by the substitution in the proviso to subregulation (1) for the expression "6 months" of the expression "12 months".
