**FORMULAE FOR DETERMINATION OF THE NUMBER OF COUNCILLORS OF
MUNICIPAL COUNCILS**

Under the powers vested in me by section 20 of the Local Government: Municipal Structures Act, 1998 (Act No. 117 of 1998), I Fholisani Sydney Mufamadi, hereby determine formulae for the determination of the number of councillors as set out in the Schedule.

SCHEDULE

Formula for determination of number of councillors for category A municipalities

1. The formula for determining the number of councillors of a category A municipality is as follows (fractions to be disregarded):

$$y = (x \div 10000) + 60$$

Where –

- (i) y represents the number of councillors; and
- (ii) x represents the number of registered voters on the municipality's segment of the national common voters roll.

Formula for determination of number of councillors for category B municipalities

- 2.(a) The formula for determining the number of councillors of a category B municipality is –

- (i) in respect of such a municipality that has less than 7 501 registered voters on its segment of the national common voters roll:

$$y = 5;$$

- (ii) in respect of such a municipality that has between 7 500 and 100 001 registered voters on its segment of the national common voters roll:

$$y = (x \div 1\,682) + 1; \text{ and}$$

- (iii) in respect of such a municipality that has more than 100 000 registered voters on its segment of the national common voters roll:

$$y = (x \div 8\,333) + 48.$$

- (b) In applying the formulae referred to in paragraph (a) -

- (i) y represents the number of councillors;
- (ii) x represents the number of registered voters on the municipality's segment of the national common voters roll; and

- (iii) fractions are to be disregarded.

Formula for determination of number of councillors for category C municipalities

3.(a) The formula for determining the number of councillors of a category C municipality is -

- (i) in respect of such a municipality that has less than 100 001 registered voters on its segment of the national common voters roll:

$$y = (x \div 9\,500) + 9; \text{ and}$$

- (ii) in respect of such a municipality that has more than 100 000 registered voters on its segment of the national common voters roll:

$$y = (x \div 12\,000) + 12.$$

(b) In applying the formulae referred to in paragraph (a) -

- (i) y represents the number of councillors;
- (ii) x represents the number of registered voters on the municipality's segment of the national common voters roll; and
- (iii) fractions are to be disregarded.

BYLAE**Formule vir die bepaling van die getal raadslede vir kategorie A munisipaliteite**

1. Die formule vir die bepaling van die getal raadslede van 'n kategorie A munisipaliteit is soos volg (breukdele moet weggelaat word):

$$y = (x \div 10000) + 60$$

Waar –

- (i) y die getal raadslede verteenwoordig; en
- (ii) x die getal geregistreerde kiesers op die munisipaliteit se segment van die nasionale gemeenskaplike kieserslys, verteenwoordig.

Formule vir die bepaling van die getal raadslede vir kategorie B munisipaliteite

- 2.(a) Die formule vir die bepaling van die getal raadslede van 'n kategorie B munisipaliteit is –

- (i) ten opsigte van sodanige munisipaliteit wat minder as 7 501 geregistreerde kiesers op daardie segment van die nasionale gemeenskaplike kieserslys verteenwoordig:

$$y = 5;$$

- (ii) ten opsigte van sodanige munisipaliteit wat tussen 7 500 en 100 001 geregistreerde kiesers op daardie segment van die nasionale gemeenskaplike kieserslys verteenwoordig:

$$y = (x \div 1682) + 1; \text{ en}$$

- (iii) ten opsigte van sodanige munisipaliteit wat meer as 100 000 geregistreerde kiesers op daardie segment van die nasionale gemeenskaplike kieserslys verteenwoordig:

$$y = (x \div 8333) + 48.$$

- (b) By die toepassing van die formules in paragraaf (a) bedoel, verteenwoordig -
- (i) y die getal raadslede;
 - (ii) x die getal geregistreerde kiesers op daardie munisipaliteit se segment van die nasionale gemeenskaplike kieserslys; en
 - (iii) breukdele moet weggelaat word.

$$y = (x \div 9\,500) + 9; \text{ en}$$

- (ii) ten opsigte van sodanige munisipaliteit wat meer as 100 000 geregistreerde kiesers op daardie segment van die nasionale gemeenskaplike kieserslys verteenwoordig:

$$y = (x \div 12\,000) + 12.$$
