

#### DETERMINATION OF THE RULES REGULATING THE PROCEEDINGS OF THE VENDA HIGH COURT OF SOUTH AFRICA

Notice is hereby given that the Judge President of the Transvaal Provincial Division of the High Court of South Africa, also as the Acting Judge of the High Court of Venda has, in terms of section 43 (2) (b) of the Supreme Court Act, 1959 (Act No. 59 of 1959), determined the rules regulating the proceedings of the High Court of Venda as follows:

(a) "Rule 1: Terms

(1) *For the year 2000:*

- (a) The third term shall be from 24 July to 22 September, inclusive; and
- (b) the fourth term shall be from 2 October to 1 December, inclusive.

(2) *For the year 2001:*

- (a) The first term shall be from 29 January to 12 April, inclusive;
- (b) the second term shall be from 23 April to 22 June, inclusive;
- (c) the third term shall be from 30 July to 28 September, inclusive; and
- (d) the fourth term shall be from 8 October to 7 December, inclusive.

(3) *For the year 2002:*

- (a) The first term shall be from 28 January to 28 March, inclusive;
- (b) the second term shall be from 8 April to 21 June, inclusive;
- (c) the third term shall be from 29 July to 27 September, inclusive; and
- (d) the fourth term shall be from 7 October to 6 December, inclusive.";

(a) "Rule 2: Administrative recesses

(1) The administrative recesses for the year 2000 shall be as follows:

- (a) From 23 September to 29 September, inclusive; and
- (b) from 1 December to 28 January 2001, inclusive.

(2) The administrative recesses for the year 2001 shall be as follows:

- (a) From 13 April to 22 April, inclusive;
- (b) from 23 June to 29 July, inclusive;
- (c) from 29 September to 7 October, inclusive; and
- (d) from 8 December to 27 January 2002 inclusive.

(3) The administrative recesses for the year 2002 shall be as follows:

- (a) From 29 March to 7 April, inclusive;
- (b) from 22 June to 28 July, inclusive;
- (c) from 28 September to 6 October, inclusive; and
- (d) from 7 December to 26 January 2003, inclusive.

(4) The Judge President shall determine prior to the commencement of the recesses referred to in subrules (1), (2) and (3) how many and which judges are to perform the functions in the said Division during the recesses.

(5) No civil or criminal business shall be heard or placed on the roll for hearing during the following terms unless a judge on duty, as referred to in subrule (4), is of the opinion that the business is urgent:

- (a) From 20 December 2000 to 2 January 2001, inclusive;
- (b) from 24 December 2001 to 4 January 2002, inclusive; and
- (c) from 23 December 2002 to 3 January 2003, inclusive."

- (c) die derde termyn is van 30 Julie tot en met 28 September; en
- (d) die vierde termyn is van 8 Oktober tot en met 7 Desember.

- (a) Die eerste termyn is van 28 Januarie tot en met 28 Maart;
- (b) die tweede termyn is van 8 April tot en met 21 Junie;
- (c) die derde termyn is van 29 Julie tot en met 27 September; en
- (d) die vierde termyn is van 7 Oktober tot en met 6 Desember."; en

**(b) "Reël 2: Administratiewe resesse****(1) Die administratiewe resesse vir die jaar 2000 is soos volg:**

- (a) Van 23 September tot en met 29 September; en
- (b) van 1 Desember tot en met 28 Januarie 2001.

**(2) Die administratiewe resesse vir die jaar 2001 is soos volg:**

- (a) Van 13 April tot en met 22 April;
- (b) van 23 Junie tot en met 29 Julie;
- (c) van 29 September tot en met 7 Oktober; en
- (d) van 8 Desember tot en met 27 Januarie 2002.

**(3) Die administratiewe resesse vir die jaar 2002 is soos volg:**

- (a) Van 29 Maart tot en met 7 April;
- (b) van 22 Junie tot en met 28 Julie;
- (c) van 28 September tot en met 6 Oktober; en
- (d) van 7 Desember tot en met 26 Januarie 2003.
