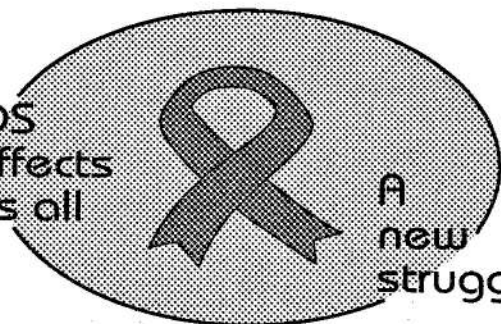

**DECLARATION OF PEACE OFFICERS UNDER SECTION 334 OF THE CRIMINAL PROCEDURE ACT, 1977
(ACT No. 51 OF 1977)**
