

I, Angela Thokozile Didiza, Minister of Agriculture, acting under sections 13 and 15 of the Marketing of Agricultural Products Act, 1996 (Act No. 47 of 1996), hereby amend the statutory measure published by Government Notice No. R. 643 of 8 May 1998 to the extent as set out in the Schedule.

1. In this Schedule any word or expression to which a meaning has been assigned in the Notice shall have that meaning, and "the Notice" means Government Notice No. R. 643 of 8 May 1998.

**Amendment of clause 10 of the Notice**

2. Clause 10 of the Notice is hereby amended by the substitution for clause 10 of the following clause:

"Commencement and period of validity

10. This statutory measure shall come into operation on the date of publication hereof and shall lapse on 28 February 2001."
