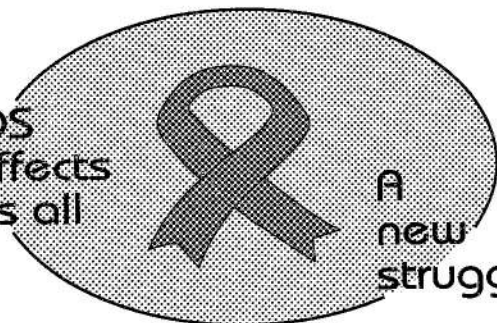

CUSTOMS AND EXCISE ACT, 1964.- IMPOSITION OF PROVISIONAL PAYMENT (VB/87)

Under section 57A(2) of the Customs and Excise Act, 1964, the period for a provisional payment in relation to anti-dumping duty on garlic, fresh or chilled and dried garlic, in the form of bulbs and cloves, imported from or originating in China, imposed under Government Notice No. R. 269 dated 24 March 2000, is hereby extended to 31 October 2000.
