MARINE LIVING RESOURCES ACT, 1998 (ACT NO. 18 OF 1998)

AMENDMENT OF REGULATIONS

The Minister of Environmental Affairs and Tourism has under Section 77 of the Marine Living Resources Act, 1998 (Act No. 18 of 1998) made the regulations as set out in the Schedule.

SCHEDULE

Definitions

1. In this Schedule "the Regulations" means the regulations published under Government Notice No. R. 1111 of 2 September 1998 as amended by Government Notices No. R. 27 of 14 January 2000 and No. 1129 of 17 November 2000.

Amendment of regulations 38 and 40 of the Regulations

2. Regulation 38 of the Regulations is hereby amended by the insertion after subregulation (3) of the following subregulation:

- "(4) A holder of a recreational abalone permit shall not engage in fishing, collecting or disturbing abalone within the area between, as a western boundary, Bot River Mouth (position 34°21'307 South, 019°04'687

East) and, as an eastern boundary, the Klein River Mouth (position 34°25'231 South, 019°18'000 East)."

3. Regulation 40 of the Regulations is hereby amended by the insertion after subregulation (1)(c) of the following subregulation:

"(d) the area between, as a western boundary, Bot River Mouth (position 34°21'307 South, 019°04'687 East) and, as an eastern boundary, the Klein River Mouth (position 34°25'231 South, 019°18'000 East)."
