ESTATE AGENCY AFFAIRS ACT, 1976 (ACT No. 112 OF 1976)

In terms of section 33 of the Estate Agency Affairs Act, 1976 (Act No. 112 of 1976), I, Alexander Erwin, Minister of Trade and Industry, hereby amend the Regulations published by Government Notice No. R. 21997 of 26 January 2001, as amended, as set out in the Schedules hereto.

### SCHEDULE A

- 1. Regulation 5(2)(c)(i) is hereby amended by-
  - (a) the substitution of the word "Minister" for the word "Board".
- 2. Regulation 8(2)(a) is hereby amended as follows-

- 3. Regulation 8(2)(b) is hereby amended by-
