**APPOINTMENT OF BLUEDOWNS AS A PLACE FOR THE HOLDING OF A COURT FOR

I, Penuell Mpapa Maduna, Minister for Justice and Constitutional Development, acting under section 2(1) of the Magistrates' Courts Act, 1944 (Act No. 32 of 1944)-

- (a) appoint Bluedowns in the district of Kuils River as a place for the holding of a court in the district of Kuils River in addition to Kuils River, the seat of magistracy;
- (b) prescribe the local limits of the district of Kuils River as the local limits within which the said court shall have jurisdiction; and
- (c) appoint Bluedowns as a place for the holding of a court for the Cape Regional Division.
