**SCHEDULE**

**Definition**

1. In this Schedule, "the Regulations" means Administrative Regulations published by Government Notice No R 1004 of 24 July 2002.

**Amendment of regulation 4 of the Regulations**

2. Regulation 4 of the Regulations is hereby amended by the substitution for sub-regulation (1) of the following sub regulation;

"(1) The initial annual PLTF for the 2002-2007 financial years must be prepared, adopted by the MEC and submitted to the Minister by the date determined by the Minister for the province concerned, in consultation with the MEC, under section (19) (4) (a) of the Act, which date must not be later than **31 March 2003.**"
