HEALTH PROFESSIONS COUNCIL OF SOUTH AFRICA**REGULATIONS RELATING TO THE REGISTRATION OF NUTRITIONISTS**

The Minister of Health has, in terms of section 61(1) read with sections 24 and 25 of the Health Professions Act, 1974 (Act No. 56 of 1974), in consultation with the Health Professions Council of South Africa, made the regulations in the Schedule.

SCHEDULE**Definition**

1. In this Schedule any word or expression to which a meaning has been assigned in the Act shall bear such meaning and, unless the context otherwise indicates –

“professional board” means the Professional Board for Dietetics established in terms of section 15 (1) of the Act; by Government Notice No. R. 314 of 27 February 1998.

“the Act” means the Health Professions Act, 1974 (Act No. 56 of 1974)

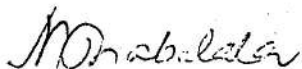
Qualification as a requirement for registration

2. The registrar may register as a nutritionist any person who –

- (a) holds an appropriate qualification, granted after examination by any institution or examining authority approved by the professional board, which includes practical experience obtained under supervision of an appropriately qualified practitioner in an accredited training institution, as prescribed for this purpose by the professional board; and
- (b) if required by the professional board, has passed an examination as may be prescribed by the professional board in terms of section 15B (1) (b) of the Act.

Information required for registration

3. Where the qualification on which an application is based has not already been approved by the professional board, the applicant shall be required to furnish the professional board, at his or her cost, with authoritative information as to the education and training required for such qualification. If the standard of such education and training is considered satisfactory and upon complying with such requirements or examination(s) as the professional board may determine, such applicant may be registered by the registrar.

BYLAE**Omskrywing**

1. In hierdie Bylae het 'n woord of uitdrukking waaraan 'n betekenis in die Wet geheg is, daardie betekenis en, tensy uit die samehang anders blyk, beteken –

"beroepsraad" die Beroepsraad vir Dieetkunde ingestel ingevolge artikel 15(1) van die Wet; by Goewermentskennisgewing No. R. 314 van 27 Februarie 1998.

"die Wet" die Wet op Gesondheidsberoep, 1974 (Wet No. 56 van 1974)

Kwalifikasie as vereiste vir registrasie

2. Die registrateur kan as voedingkundige registreer iemand wat –
 - (a) beskik oor 'n toepaslike kwalifikasie toegestaan na eksaminering deur 'n instelling of eksamenowerheid wat deur die beroepsraad goedgekeur is, wat insluit praktiese ondervinding verkry onder toesig van 'n toepaslik gekwalifiseerde praktisyn in 'n geakkrediteerde opleidingsinstelling, soos vir hierdie doel deur die beroepsraad voorgeskryf; en
 - (b) indien deur die beroepsraad vereis, 'n eksamen geslaag het soos deur die beroepsraad kragtens artikel 15B(1) (b) van die Wet voorgeskryf kan word.

Inligting benodig vir registrasie

3. Waar, die kwalifikasie waarop 'n aansoek gebaseer is, nie reeds deur die beroepsraad goedgekeur is nie, sal daar van die aansoeker vereis word om op eie koste die beroepsraad te voorsien van gesaghebbende inligting betreffende die onderwys en opleiding vereis vir sodanige kwalifikasie. Indien die standaard van sodanige onderwys en opleiding as bevredigend beskou word en by voldoening aan sodanige vereistes of eksamen(s) as wat die beroepsraad bepaal, kan sodanige aansoeker deur die registrateur geregistreer word.

The National Treasury has embarked on the process of providing guidance to PPPs on the content of the legal document that governs the relationship between the private party and the public entity. This document is termed the Standardised PPP Provisions. It is envisaged that its contents will provide guidance to and be binding on parties to Public Private Partnerships.

The National Treasury considers it essential that the process preceding the issue of the Standardised PPP Provisions is consultative and inclusive of all stakeholders. The draft document that reflects the position of the public sector was presented to the private sector on the 6th May 2003. All interested parties originally had until the 19th June 2003 to provide their comments—this date has been extended to the 6th July 2003.
