CUSTOMS AND EXCISE ACT, 1964 AMENDMENT OF SCHEDULE NO. 1 (NO. 1/1/1217)

Government Notice No. R. 1070 of 1 August 2003 appearing in Government Gazette No. 25245 is hereby amended:

- (a) By the substitution for the expression "By the substitution for subheadings 22.02 and 22.03 of the following:" by the expression "By the substitution for subheading 22.02 of the following:" where it appears in the column headed "Article Description" appearing against headings 22.02 and 22.03; and
- (b) By the deletion of all references to heading 22.03 and all particulars against this heading.
