PROPOSED AMENDMENT TO THE CIVIL AVIATION REGULATIONS. 1997

Under regulation 11.03.2(1)(a) of the Civil Aviation Regulations,1997, the Chairperson of the Civil Aviation Regulations Committee (CARCOM), hereby publishes for comment the proposed amendment to the Civil Aviation Regulations, 1997, as set out in the schedule below. 1. Proposal to amend the Civil Aviation Regulations of 1997

Proposer:

Explanation of interest of the Proposer

The Proposer administers the Aviation Act, 1962 (Act No. 74 of 1962) and regulations and technical standards issued in terms thereof.

Proposed amendment of Part 11 of the CAR

- 1.1 It is proposed to amend regulation 11.03.2 (Processing and consideration of proposals) by the substitution of paragraph (b) of sub-regulation (4) with the following paragraph:
 - "(b) Publish the proposed regulation or technical standard, amendment or withdrawal, as agreed upon by the committee following its deliberations referred to in sub-

regulation (3), as proposed rule-making by notice in the Gazette if it relates to the regulations, and by notice on the CAA website if it relates to the technical standards.".

1.2 Motivation

The process of publishing proposals for technical standards, their amendment or withdrawal is a lengthy and costly process. It is difficult to synchronise such proposals with the proposals for the making, amendment or withdrawal of related regulations. Furthermore, technical standards are often of interest only to a limited number of people.

By utilising the internet for communication and consultation, the process can be speeded up and reduced in cost dramatically without either participation or transparency being adversely affected. In fact, as will be explained in the motivation for the insertion of a new regulation 11.03.3, the proposed new system will alert interested parties to any proposed changes in the regulations.

1.3 Current regulation

- "(b) Publish the proposed regulation or technical standard, amendment or withdrawal, as agreed upon by the committee following its deliberations referred to in subregulation (3), as proposed rule-making by notice in the Gazette if it relates to the regulations, and by notice in an AIC if it relates to the technical standards.".
- 2.1 It is proposed to insert the following new regulation 11.03.3:

"Rule-making notification subscriber service

- 11.03.3 (1) To facilitate the consultation process, the

 Commissioner shall make available on the CAA

 website a rule-making notification subscriber
 service to which any person may subscribe and
 unsubscribe at no cost. Subscribers shall be
 notified by email of any proposal to make, amend
 or withdraw any regulation or technical standard,
 and of any related matter, including the proposals
 referred to in paragraph (4)(b) above.
 - (2) Any technical standard issued shall be published on the CAA website for free downloading, and may be ordered from the CAA in either hard copy or electronic format at the published price.".

2.2 Motivation

As explained in the motivation for the amendment of paragraph (b) of sub-regulation 11.03.2(4) above, a more efficient and costeffective process for the consultation on any proposed issue, amendment or withdrawal of technical standards is required. The proposed rule-making notification subscriber service meets this requirement, and has the advantage that subscribers may also be alerted to other legislation-related matters.

A similar system is in operation with the Australian CASA.

2.3 **Current regulation**

The proposal is for a new regulation.
