PROCLAMATION*by the**President of the Republic of South Africa*

No. R. 65, 2003

THE APPOINTMENT OF MEMBERS OF THE TAX COURTS

Whereas the persons mentioned in Schedule A to this Proclamation are suitable for appointment for the first time as members of the Tax Courts constituted in accordance with the provisions of section 83(3) of the Income Tax Act, 1962 (Act No. 58 of 1962) ("the Act");

And whereas by Proclamation No. 77 of 1997, the persons mentioned in Schedule B to this Proclamation were previously appointed or re-appointed under the provisions of section 83(5)(a) and (b) of the Act as members of the said Tax Courts;

And whereas the appointments of the latter members expired on 28 November 2002;

Now therefore under the powers vested in me by section 83(5)(a) of the Income Tax Act, I do hereby appoint the persons mentioned in Schedule A to this Proclamation as members of the said Tax Courts for a period of five years from the date of this proclamation, subject to the provisions of the proviso to section 83(5)(a) of the Act.

And further, under the powers vested in me by section 83(5)(b) of the Act, I do hereby re-appoint the persons mentioned in Schedule B to this Proclamation as members of the said Tax Courts for a further period of five years from the date of this Proclamation, subject to the provisions of the proviso to section 83(5)(a) of the Act.

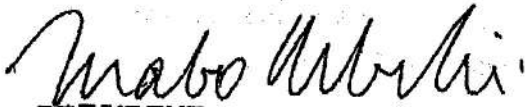
