CUSTOMS AND EXCISE ACT, 1964 AMENDMENT OF RULES (NO. DAR/99)

Under section 120 of the Customs and Excise Act, 1964, the rules published in Government Notice R.1874 of 8 December 1995 are amended with effect from 1 August 2004 to the extent set out in the Schedule hereto.

SCHEDULE

(a) By the substitution for the heading to the rules numbered 120B of the following heading:
"Procedures in respect of goods carried by road on the Trans Kalahari Route"

- (b) by the substitution for paragraph (a) of rule 120B.01 of the following paragraph:
 - "(a) The provisions of these rules apply only -
 - (i) in respect of goods carried by road on the Trans Kalahari Route; and
 - (ii) in the case of goods so carried from the Republic of South Africa, in respect of goods entered for such carriage at the office of the Controller for Johannesburg, Johannesburg International Airport, Germiston, Ramathlabama or Skilpadshek."
- (c) by the substitution for rule 120B.02 of the following rule:

"120B.02 Notwithstanding anything to the contrary in rule 120A.01 or any other rule the SAD 500, SAD 501, SAD 502 and SAD 503 must be used instead of form CCA1 for the purposes of any relevant customs and excise procedure regulating the movement of goods where such goods are carried by road from the Republic of South Africa on the Trans Kalahari Route."

(d) by the substitution for rule 120B.03 of the following rule:

"120B.03 The following forms are prescribed for the purposes contemplated in these rules:

- (a) The SAD 500 Customs Declaration Form which must be completed in respect of the movement of the goods in respect of this rule;
- (b) the SAD 501 Customs Declaration Form (Continuation Sheet) which must be completed if more than one item segment is declared;
- (c) the SAD 502 Customs Declaration Form (Transit Control) is the reverse side of the SAD 500;
- (d) the SAD 503 Customs Declaration Form (Bill of Entry Query Notification / Voucher of Correction) which is used for the correction of the SAD 500."

(e) by the substitution for paragraphs (a) and (b)(i) of rule 120B.04 of the following paragraphs:

"(a) A copy of the SAD 500 with the SAD 502 duly completed to the extent applicable by all the offices on the route and including the office of final destination must be returned to the Controller at the office of commencement in the Republic within a period of 30 days after such entry.

- (b) (i) Notwithstanding these provisions, any person is absolved from complying with any other prescribed requirement, as may be applicable in each case, relating to the entry and removal in bond or entry for and export of the goods carried on the Trans Kalahari Route; and"
- *f)* by the substitution in item 202.00, Prescribed Forms, of the following forms:
 - "SAD 500 Customs Declaration Form;




