PETROLEUM PRODUCTS ACT, 1977 (ACT No. 120 OF 1977)

REGULATIONS IN RESPECT OF THE MAXIMUM RETAIL PRICE OF ILLUMINATING
PARAFFIN

1. I, Phumzile Mlambo-Ngcuka, Minister of Minerals and Energy, under section 2 (1) (c) of the Petroleum Products Act, 1977 (Act No. 120 of 1977), determine that a maximum retail price for illuminating paraffin (excluding the price of any form of packaging) will become effective on the first Wednesday of each month.

2. The maximum retail price for illuminating paraffin, excluding the price of any form of packaging, for the period 1 December 2004 to 4 January 2005 will be 425,0 c/l.

Commencement

These regulations shall come into operation at 00:01 on 1 December 2004.

PETROLEUM PRODUCTS ACT, 1977
(ACT No. 120 of 1977)

AMENDMENT OF THE REGULATIONS IN RESPECT OF PETROLEUM PRODUCTS
