ESTABLISHMENT OF STATUTORY MEASURE: RECORDS AND RETURNS
BY ABATTOIRS AND OTHER ROLE - PLAYERS

I, Angela Thokozile Didiza, Minister of Agriculture, acting under sections 13 and 18 of the Marketing of Agricultural Products Act, 1996 (Act No. 47 of 1996), hereby establish the statutory measure set out in the Schedule.

SCHEDULE

Definitions

1. In this Schedule any word or expression to which a meaning has been assigned in the Act shall have that meaning, and unless the context otherwise indicates –

“designated animal” for purposes of this notice, means cattle, goats, pigs and sheep;

“levy notice” means any notice whereby a levy is imposed on a designated animal or any meat product derived from a designated animal in terms of the Act;

“levy administrator” means the levy administrator as defined in the levy notice; and

“the Act” means the Marketing of Agricultural Products Act, 1996 (Act No. 47 of 1996).

Purpose and aim of statutory measure and the relation thereof to the objectives of the Act

2. The purpose and aims of this statutory measure is to compel the parties set out herein to render records and returns to the levy administrator. This is necessary to ensure that continuous, timeous and accurate information relating to designated animals slaughtered and marketed is available to all role - players. Market information is deemed essential for all role - players in order for them to make informed decisions. By prescribing the keeping of records with the rendering of returns on an individual basis, market information for the whole of the industry can be processed and disseminated.

The establishment of the statutory measure should assist in promoting the efficiency of the marketing of meat. The viability of the red meat industry should thus be enhanced.

The measure is not detrimental to any of the objectives of the Act, and in particular will not be detrimental to the number of employment opportunities or fair labour practice in the red meat industry.

Any information obtained through this mechanism will be dealt with in a confidential manner and no sensitive or potentially sensitive client-specific

information will be made available to any party without the prior approval of the party whose rights are affected.

The measure will be administered by the levy administrator, who will act in terms of the mandate and on behalf of the red meat industry through its representative organ, namely the Red Meat Industry (RMIF).

Products to which statutory measure applies

3. This statutory measure shall apply to designated animals and any meat product derived there from.

Area in which statutory measure shall apply

4. This statutory measure shall apply in the geographical area of the Republic of South Africa.

Records to be kept and returns to be rendered

5. (1) Any person referred to in clause 5(a), (b) or (c) of the levy notice, with the exception of persons referred to in clause 5(a)(i) and 5(b)(i) thereof, shall keep such records and render the returns as may be required by the levy administrator for designated animals and meat products.

(2) The records referred to in subclause (1) shall –

- (a) be recorded on a computer or with ink in a book;
- (b) be kept at the registered premises of the person required to keep it for a period of at least three years.

(3) The returns referred to in subclause (1) shall be rendered on a form obtainable free of charge for this purpose from the levy administrator and shall –

Commencement and period of validity

6. This statutory measure shall come into operation on 90 days after the date of publication hereof and lapse two years later.

Woordomskrywing

1. In hierdie bylae het enige woord of uitdrukking waaraan 'n betekenis volgens die Wet toegeken is, daardie betekenis dra tensy die konteks anders bepaal, en beteken –

2. Die doel en oogmerke van hierdie statutêre maatreël is om die partye hierin uiteengesit te noop om opgawes en verslae aan die heffingsadministrateur in te handig. Dit is om te verseker dat aaneenlopende, akkurate inligting rakende geslagte en bemarkte diere betyds aan alle rolspelers beskikbaar is. Markinligting is noodsaaklik vir alle rolspelers om ingeligte keuses te kan uitoefen. Die byhou van opgawes met die inhandiging van verslae op 'n individuele basis beteken markinligting kan geprosesseer en aan die hele bedryf versprei word.

Die daarstelling van die statutêre maatreël moet help om die effektiwiteit van vleisbemarking te bevorder. Die lewensvatbaarheid en effektiwiteit van die rooivleisbedryf behoort dus verhoog te word

Hierdie statutêre maatreël is nie nadelig vir enige van die doelwitte van die Wet nie en sal, in besonder, nie nadelig vir die aantal werkseleenthede of regverdige arbeidspraktyk in die rooivleisbedryf wees nie.

I, Angela Thokozile Didiza, Minister of Agriculture, acting under sections 13 and 15 of the Marketing of Agricultural Products Act, 1996 (Act No. 47 of 1996), as amended, hereby establish the statutory measure set out in the Schedule.

SCHEDULE**Definitions**

1. In this Schedule any word or expression to which a meaning has been assigned in the Act shall have that meaning, and unless the context otherwise indicates –

“abattoir” means any place where a designated animal is slaughtered for any intended use other than own non-commercial use;

“designated animal” for purposes of this notice, means cattle, goats, pigs and sheep;

“head” means one designated animal;

“hides and skins” means the hides and skins of designated animals;

“livestock agent” means any person acting as such, whether the risk of ownership of designated animals pass to him or not;

“levy administrator” means the levy administrator as defined in the Levy Notice;

“red meat” means the meat of designated animals;

“meat product” means any red meat, processed and manufactured red meat product intended for human consumption;

“meat retail outlet” means any outlet where red meat is sold, whether operated independently or as part of a group or chain of meat outlets;

“meat processor” means any person (inclusive of establishment and/or institution) that enhances red meat further than deboning and portioning, dicing or mincing for commercial purposes;

“the Act” means the Marketing of Agricultural Products Act, 1996 (Act No. 47 of 1996), as amended.

Purpose and aim of statutory measure and the relation thereof to the objectives of the Act

2. The red meat industry is the single largest agricultural sector in South Africa. As such there are a variety of functions that have been identified as crucial to the future development and sustainability of the sector for which a levy is a necessity. These functions are:

- (a) Consumer Assurance
- (b) Consumer Communication and Education
- (c) Development of Developing Sector
- (d) Research and Development
- (e) Industry Liason
- (f) Industry Projects
- (g) Production Development

The levy is not detrimental to any of the objectives of the Act, and in particular will not be detrimental to the number of employment opportunities or fair labour practice in the red meat industry.

The statutory measure will be administered by the levy administrator, who will act in terms of the mandate and on behalf of the red meat industry through its representative organ, namely the Red Meat Industry Forum.

The statutory measure is necessary to finance the above-mentioned functions and the levy will be utilized in accordance with the levy application submitted to the Minister. The Auditor-General will also be responsible to audit the statutory levies collected.

The actual beneficiaries of the levy will be determined by the Red Meat Industry Forum in accordance with the approved business plan and budget for the purposes set out above.

3. Products to which statutory measure applies

This statutory measure shall apply to all designated animals and products from these animals as well as any red meat products imported into the Republic of South Africa.

4. Area in which measure shall apply

This measure shall apply in the geographical area of the Republic of South Africa.

5. Imposition of levy

A levy is hereby imposed on each category of designated animal and product as follows:

a. Beef

	Levy	Description
i	R 3.00 per head	Deducted and retained from the selling price of each animal by any buyer of such animal
ii	R 5.00 per head	Deducted by the abattoir at slaughter from the person presenting such animal for slaughter and paid over to the levy administrator
iii	R 300 per year	Payable by each meat retail outlet and paid over to the levy administrator
iv	R 0.03 per kg	Payable by the importer of beef products at point of entry and paid over to the levy administrator
v	R 5.00 per head	Payable by the exporter of live animals at the point of exit and paid over to the levy administrator
vi	0.07% of the commission	Payable by the livestock agent per head sold and paid over to the levy administrator
vii	R 0.01 per kg	Payable by the processor of locally produced hides and paid over to the levy administrator. The same amount will also be collected for every unprocessed hide exported, paid by the exporter to the levy administrator

b. Sheep and goats

	Levy	Description
i	R 0.50 per head	Deducted and retained from the selling price of each animal by any buyer of such animal
ii	R 0.75 per head	Deducted by the abattoir at slaughter from the person presenting such animal for slaughter and paid over to the levy administrator

iii	R 300 per year	Payable by each meat retail outlet and paid over to the levy administrator
iv	R 0.03 per kg	Payable by the importer of sheep and goat meat products at point of entry and paid over to the levy administrator
v	R 0.75 per head	Payable by the exporter of live animals at the point of exit and paid over to the levy administrator
vi	0.07% of the commission	Payable by the livestock agent per head sold and paid over to the levy administrator
vii	R 0.01 per kg	Payable by the processor of locally produced skins and paid over to the levy administrator. The same amount will also be collected for every unprocessed skin exported, paid by the exporter to the levy administrator

c. Pigs

	Levy	Description
i	R 5.20 per head	Deducted by the abattoir at slaughter from the person presenting such animal for slaughter and paid over to the levy administrator
ii	R 300 per year	Payable by each meat retail outlet and paid over to the levy administrator
iii	R 0.03 per kg	Payable by the importer of pork meat products at point of entry and paid over to the levy administrator
iv	R 5.20 per head	Payable by the exporter of live animals at the point of exit and paid over to the levy administrator
v	0.07% of the commission	Payable by the livestock agent per head sold and paid over to the levy administrator
vi	R 0.01 per kg	Payable by registered processors for pig carcasses purchased for processing, and paid over to the levy administrator

Note: Meat retailers pay R300 per outlet irrespective if they sell one specie or all three species.

Persons by whom and to whom levy shall be payable

6. The levy imposed under clause 5 shall be payable by the persons set out in that clause to the levy administrator or his designated agent within the period set out in clause 8.

Guideline prices

7. The guideline prices for the different designated animals and its products will be as follows:

a. Cattle

i. Cattle	R 2 762 per head
ii. Carcass price	Average price = R 13/kg
iii. Meat imported	Average price = R 7/kg
iv. Cattle exported live	R 2 762 per head

i. Sheep and goats	R 280 per head
ii. Carcass price	Average price = R 5/kg
iii. Meat imported	Average price = R5/kg

c. Pigs

<u>Category</u>	<u>Guideline price</u>
i. Pigs	R 560 per head
ii. Carcass price	Average price = R 10/kg
iii. Meat imported	Average price = R 10/kg

Payment of levy

8. (1) A levy imposed in terms of this notice shall be paid to the levy administrator:
- In the case of an event referred to in clause 5(a) ii, iv, v, vi and vii, 5(b) ii, iv, v, vi and vii and 5(c) i, iii, iv, v and vi, within 14 days of any event taking place; and
 - In the case of an event referred to in clause 5(a)iii, 5(b)iii and 5(c) ii, on or before the last day of March in each calendar year.
- (2) Payment shall be made by means of a cheque or electronic bank transfer in favour of the levy administrator, and shall –
- When paid by cheque, be addressed to –

 - When electronically transferred, be paid to the account number obtainable from the levy administrator.

Use of levy

9. The Minister approve that –
- at least 70% of the levy funds should be used for the core business
 - not more than 10% for administrative use; and
 - approximately 20% be allocated towards transformation.

MARKETING OF AGRICULTURAL PRODUCTS ACT, 1996
(ACT No. 47 OF 1996)

ESTABLISHMENT OF STATUTORY MEASURE: REGISTRATION

I, Angela Thokozile Didiza, Minister of Agriculture, acting under sections 13 and 19 of the Marketing of Agricultural Products Act, 1996 (Act No. 47 of 1996), hereby establish the statutory measure set out in the Schedule.

SCHEDULE

Definitions

1. In this Schedule any word or expression to which a meaning has been assigned in the Act shall have that meaning, and unless the context otherwise indicates –

“designated animal” for purposes of this notice, means cattle, goats, pigs and sheep;

“levy notice” means any notice whereby a levy is imposed on a designated animal or any meat product derived from a designated animal in terms of the Act;

“levy administrator” means the levy administrator as defined in the levy notice; and

“the Act” means the Marketing of Agricultural Products Act, 1996 (Act No. 47 of 1996).

Purpose and aim of statutory measure and the relation thereof to the objectives of the Act

2. The purpose and aims of this statutory measure is to compel the parties set out herein to register with the Levy Administrator. This is necessary to ensure that continuous, timeous and accurate market information relating to animals slaughtered and marketed is available to all role - players. Market information is deemed essential for all role - players in order for them to make informed decisions.

The establishment of the statutory measure should assist in promoting the efficiency of the marketing of meat. The viability of the red meat industry should thus be enhanced.

The measure is not detrimental to any of the objectives of the Act, and in particular will not be detrimental to the number of employment opportunities or fair labour practice in the red meat industry.

The statutory measure will be administered by the levy administrator, who will act in terms of the mandate and on behalf of the red meat industry through its representative organ, namely the Red Meat Industry Forum (RMIF).

Products to which statutory measure applies

3. This statutory measure shall apply to designated animals and any meat product derived there from.

Area in which statutory measure shall applies

4. This statutory measure shall apply in the geographical area of the Republic of South Africa.

Registration

5. (1) Any person referred to in clause 5(a), (b) or (c) of the levy notice, with the exception of persons referred to in clause 5(a)(i) and 5(b)(i) shall on an annual basis register and re-register with the levy administrator.

(2) Registration shall be done immediately upon receipt of a registration form obtainable free of charge for this purpose from the levy administrator, and must -

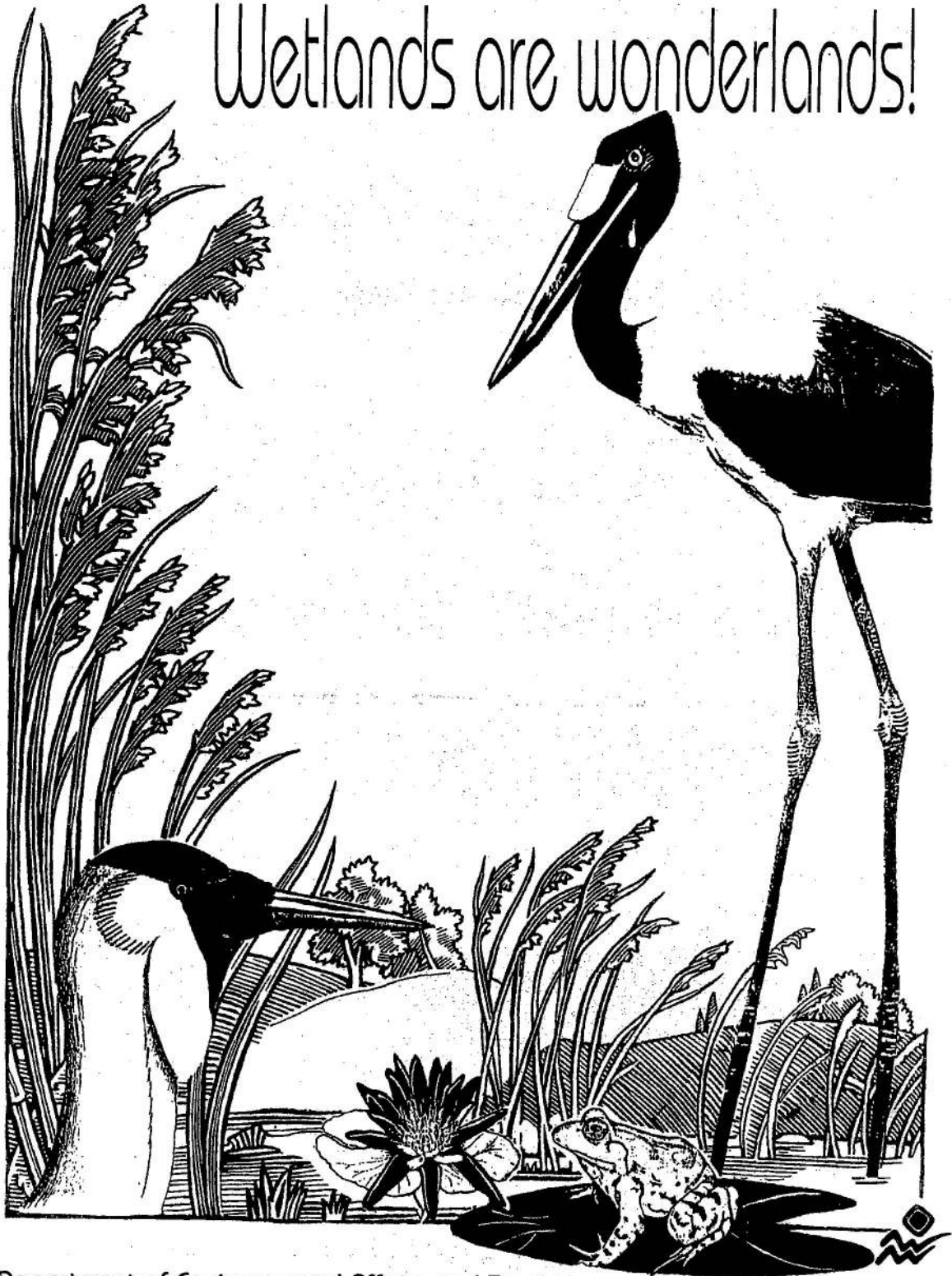
