REPEAL OF REGULATIONS MADE UNDER THE SOCIAL SERVICE PROFESSIONS ACT, 1978

The Minister of Social Development hereby repeals the regulations regarding the establishment and constitution of a professional board for probation services made under the Social Service Professions Act, 1978 (Act No. 110 of 1978) and published as Government Notice R. 744 in Government Gazette 26478 of 25 June 2004.
