1 (1) Lezi zimiso zomthetho ziyiZimiso Zomthetho Wokuvikela Abathengi.

(2) Kulezi zimiso, ngaphandle uma ngabe isimo sikhombisa ngenye indlela, nanoma yiliphi igama noma izwi elinikezwe incazelo eMthethweni linencazelo efanayo, futhi- "Umthetho" usho Umthetho Wokuvikela Abathengi, 2008 (Umthetho 68 ka-2008); "Umnyango" kusho Umnyango Wezohwebo Nezimboni; "ngokubhala" kubandakanya izindlela nanoma yiziphi ze-elektroniki ezihlonishwa nguMthetho Wezokuxhumana Nge-elektroniki kanye Nemisebenzi, 2002 (Umthetho 25 ka-2002); futhi "umsebenzi kahulumeni" kusho umuntu ochazwe eSihlokweni III (Ukuhlinzeka Okujwayelekile) seNgxenye V yoMthetho Wentela Yemali Engenayo, 1962 (Umthetho 58 ka-1962).

Izivumelwano zefreyintshazi

2 (1) Izimiso zomthetho kufanele zifundwe kanye kanye nezigaba 7 no-120(1)(e)(ii) zoMthetho.

(2) (a) Isivumelwano ngasinye sefreyintshazi kufanele sibe nombhalo ongenaphutha wesigaba 7(2) soMthetho phezulu ekhasini lokuqala lesivumelwano sefreyintshazi, kanye kanye nereferensi yesigaba kanye noMthetho.

- (b) Isivumelwano sefreyintshazi kufanele sibe nokuhlinzeka okuvimbela -
 - (i) ukuhlolwa kwezimali okungenamqondo noma okweqile, amanani entengo noma okunye okucatshangwayo okuqondile noma okungaqondile;
 - (ii) ukuziphatha okungenasidingo noma okungenamqondo maqondana nezingozi ezizothwala ngomunye umuntu; futhi
 - (iii) ukuziphatha okungenamqondo odingekayo ukuvikela izintshisekelo zebhizinisi elisemthethweni lomuntu onikezele ngefreyintshazi, umuntu othole ifreyintshazi noma uhlelo lwefreyinthazi.
 - (c) Isivumelwano sefreyintshazi kufanele sibe nesigatshana esazisa umuntu onikezele ngefreyintshazi ukuthi yenaakanalungelo kunanoma iyiphi inzuko engadaluliwe eqondile noma engaqondile noma isinxephezelo esivela kubanikezeli bempahlala siya kubantu abathole kuye ifreyintshazi noma uhlelo lwefreyintshazi, ngaphandle uma umniningwane udaluliwe ngokubhala okunencazelo yokuthi kuzosebenza kanjani.
 - (d) Indima yesi-2 yephuzu lesi-3 leSheduli yesi-2 yoMthetho isebezena kunanoma yisiphi isivumelwano sefreyintshazi ebikhona ngaphambilini.
 - (e) Nanoma yikuphi ukuhlinzeka esivumelwaneni sefreyintshazi okusebenza kuso lezi zimiso zomthetho okulwisana nalesi simiso somthetho sikhanselwe kangangezinga laleyo ngxabano.
- (3) Isivumelwano sefreyintshazi kufanele njengokuphansi sibe nolwazi oluthize ngqo olulandelayo –

 - (d) incazelo yohlelo lwebhizinisi lwefreyintshazi efanele;
 - (e) okucatshangwayo okuqondile noma okungaqondile okufanele kukhokhwe ngumuntu onikwe ifreyintshazi kumuntu onikezele ngefreyintshazi;
 - (f) amalungelo okuvikeleka, uma ekhona, anikezelwe kumuntu onikwe ifreyintshazi ngemininingwane egcwele;
 - (g) incazelo yesayithi noma yamagceke kanye nendawo lapho umuntu onikwe ifreyintshazi ezoqhuba khona ifreyintshazi;

- (h) izimo umuntu onikwe ifreyintshazi angadlulisela noma anikezele ngaphansi kwazo umhlaba wakhe amalungelo kanye nezibopho ngaphansi kwefreyintshazi;
- (i) incazelo yophawu lokuhweba noma nanoma yikuphi okunye okuyimpahla ebhaliwe komuntu onikezela ngefreyintshazi, noma ngenye indlela umuntu onikezela ngefreyintshazi akanelayisense yakho esetshenziswayo, noma ezosetshenziswa kufreyintshazi, kanye nezimo okungasetshenziswa ngaphansi kwazo;
- (j) uma isivumelwano siphathelene nefreyintshazi enkulu, ukwaziswa komuntu onikezela ngefreyintshazi kwabanye;
- (k) imininingwane yokuqeleshwa kokuqala kanye nosizo olunikezwa umuntu onikezela ngefreyintshazi kanye, nalapho umuntu onikezela ngefreyintshazi enikezela ngokuqeleshwa okuqhubekeyo isikhathi sesivumelwano sefreyintshazi, isitatimende lapho okuzonikezelwa khona imininingwane yalokho kuqeleshwa nosizo kuzonikezelwa kumuntu onikezwe ifreyintshazi uma kunesidingo;
- (l) isikhathi kanye nemithetho yokuvuselelwa kwesivumelwano sefreyintshazi, uma kungukuthi imithetho kanye nemibandela akuhambisani nenhoso kanye nenqubomgommo yoMthetho;
- (m) uma isivumelwano sefreyintshazi sihlinzeka ngokuthi umuntu onikezwe ifreyintshazi kufanele afake isandla ngokuqondile noma ngokungaqondile ekukhangiseni, ekumaketheni noma kwesinye isikhwama esifanayo, isivumelwano sefreyintshazi kufanele sibe nezigatshana ezazisa umuntu onikezwe ifreyintshazi –
- (i) yenani, noma uma ishiwo njengephesenti, indlela yokuba la lowo mnikelo;
- (ii) ezinyangeni eziyisithupha emva kokuphela konyaka wezimali wokugcina, umuntu onikezele ngefreyintshazi uzonikezela umuntu onikezwe ifreyintshazi ikhophi yesitatimende sezimali, esilungiswe ngokuhambisana nomthetho osebenzayo, okungakhombisa kancane izimali ezingeni kanye nezindleko zonyaka wokugcina wezimali, kubandakanya imali esetshenzisiwe, kanye nendlela yokusebenzisa ekukhangiseni kanye/noma ekumaketheni komuntu onikezwe ifreyintshazi kanye nezimpahla nezinsizakalo zohlelo lwefreyintshazi
- (iii) ukuthi, ukwengeza endinyaneni (ii), umuntu onikezela ngefreyintshazi kufanele njalo esikhathini esiyizinyanga ezintathu enze ama-akhawunti

- okuphathwa kwezimali okuphathelene nezimali ezitholwa ngumuntu onikezwe ifreyintshazi;
- (iv) ukuthi izimali esikhwameni zingeze zachithwa ekukhangiseni nasekumaketheni kwamafreyintshazi athengisayo omuntu onikezela ngefreyintshazi;
- (v) ukuthi kuze kube lapho okwenziwa khona ucwaningo lwamabhku, isitifiketi somcwaningi wamabhku obhalisile noma umsebenzi obheka amabhku ezimali, njengoba kungenzeka, eqinisekisa ukuthi i-akhawunti yesikhwama icutshunguliwe nokuthi izitatimende, ngokwazi kwakhe kahle hle, zinikeza isithombe esiyiqiniso sezindaba ezishiwo esimisweni esincane (m) kanye nalapho okungenziwanga khona ucwaningo, isitifiketi esenziwe umbheki wamabhku ezimali ukuthi ama-akhawunti okuphatha alungisiwe futhi alungile ngokolwazi lwabaqondisi;

- (vii) ananoma yimuphi umnikelo waleso sikhwama uzodiphozithwa ku-akhawunti yasebhange eseceleni futhi usetshenziselwe kuphela izinhloso zesikhwama;
- (viii) umnikelo womuntu onikezela ngefreyintshazi kuleso sikhwama, uma ukhona; kanye
- (ix) nokuthi umuntu onikezela ngefreyintshazi kanye/noma amabhizinisi angamafreyintshazi aphathelene nomuntu onikezela ngefreyintshazi awathola nanoma iyiphi inzuzo eqondile noma engaqondile enganikwanga abantu abanikezelwe ifreyintshazi abazimele;
- (n) umphumela wokumiswa noma wokuphela kwasikhathi sefreyintshazi;
- (o) imibandela yokwelula noma yokuvuselela, noma ukuthi ingabe lukhona yini ukhetho lokuvuselela noma lokwelula isivumelwano;
- (p) incazel ebhaliwe yananova yimithi imithetho noma izigaba ezingaqondwa ngokugcweliwe ngumuntu onokanezelwa ifreyintshazi esikhathini esizayo ngesicelo somuntu ozonikezwa ifreyintshazi esikhathini esizayo esibhaliwe;

- (q) igama elisemthethweni lomuntu onikezela ngefreyintshazi, igama lokuhweba, ihhovisi elirejistiwe kanye nehhovisi lebhizinisi lefreyintshazi, igama lomgwaqo, ikheli leposi, ikheli le-emeyili, inamba yocingo kanye nenamba yefeksi;
- (r) igama, inamba kamazisi, idolobha ahlala kulo, amagama omsebenzi kanye neziyu zabaqondisi bomuntu onikezela ngefreyintshazi noma abasebenzi abalingana nabo;
- (s) ngaphandle kwala umuntu onikezela ngefreyintshazi kuyinkampani erejistwe ku-stock exchange, imininingwane yomnikazi, ilungu noma umnikazi wamasheya uma behlukile kubantu abashiwo endimeni (r);
- (t) imininingwane yananoma yimiphi imingcele ebekelwe umuntu onikezwe ifreyintshazi;
- (u) isimo kanye nobungako bokubandakanya komuntu onikezele ngefreyintshazi noma imvume ohlelweni lokukhetha indawo;
- (v) imithetho kanye nemibandela ephathelene nokumiswa, ukuvuselela, isihle kanye nokunikezwa kwefreyintshazi;

 - (ii) izimali ezidingekayo ukwakha ibhizinisi eliyifreyintshazi kubandakanya, ukuthenga noma ukuqasha indawo, izindleko zokuguqula isayithi, ukuhlobisa kanye nezimpawu, izimpahla zokusebenza, ifenisha, ukuqasha nokuqequesha abasebenzi, isitokwe sokuvula, izinhlawulo eziemthethweni nezezimali, njengoba zingasebenza;
 - (iii) imali yokwenza umsebenzi yokuqala, lapho okunokwenzeka khona, kanye nesikelo okubalelwa kuso;
 - (iv) imali etshaliwe yonke edingekayo;

- (v) isitatimende esicacile sokuthi ingabe kukhona yini izindleko noma cha, kukhona yini imiholo yenyanga/yesonto yabasebenzi bebhizinisi eliyifreyintshazi kanye nezindleko zemalimboleko yokusevisa kubandakanyiwe yini enanini lentengo lokuthenga.
 - (vi) inani lokuxhasa ngemali elikhona elivel a kumuntu onikezela ngefreyintshazi, uma ikhona, kanye nezimo ezisebenzayo;
 - (vii) inani lemali lonke okufanele likhishwe umuntu onikezwe ifreyintshazi maqondana nokuxhasa ngemali okudingekayo ngaphambi kokuboleka; kanye
 - (viii) namanani aqhubekayo akhokhelwa umuntu onikezela ngefreyintshazi, nemininingwane yokuthi-
 - (aa) ingabe amanani emali awaguuki yini noma ayaguuka;
 - (bb) ingabe onke noma ingxene yamanani emali afakiwe yini enanini lentengo lezimpahla noma amasevisi okufanele athengwe kumuntu onikezela ngefreyintshazi noma abanye abanikezeli abafunwayo;
 - (cc) izinsuku, noma izikhawu, izimali okufanele zikhokhwe ngazo; futhi
 - (dd) uma kunanoma iyiphi imali ekhokhwa maqondana nezinsizakalo zokuphatha ezhilinzekwa umuntu onikezela ngefreyintshazi, imininingwane yalezo zinsizakalo.
- (4) Isivumelwano sefreyintshazi esivuselelwa emva kosuku olujwayelekile lokusebenza isivumelwano esisha sefreyintshazi sezinhloso zezimiso zemithetho ezincane (2) kanye no- (3).

Umbhalo wokudalula womuntu ozonikezelwa Ifreyintshazi esikhathini esizayo

- 3 (1) Wonke umuntu onikezela ngefreyintshazi kufanele anikeze umuntu ozonikezwa ifreyintshazi esikhathini esizayo umbhalo wokudalula, ofakwe usuku futhi wasayinwa umsebenzi ogunyaziwe womuntu onikezela ngefreyintshazi, okungenani ezinsukwini eziyi-14 ngaphambi kokusayinwa kwesivumelwano sefreyintshazi, okufanele njengesiphansi sibe -
- (a) nesibalo sezitolo ngazinye ezinikezelwe ifreyintshazi ngumuntu onikezela ngefreyintshazi;

- (b) nokukhula kwembuyiselo yomuntu onikezela ngefreyintshazi, inzuzo esele kanye nenamba yezipolo ngazinye, uma zikhona, ezinikezelwe ifreyintshazi ngumuntu onikezela ifreyintshazi ngonyaka wezezimali ngaphambi kosuku umuntu ozonikezwa ifreyintshazi esikhathini esizayo ethola ikhophi yombhalo wokudalula;
- (c) isitativende esiqinisekisa ukuthi azange kube nezinguquko zezinto ezinkulu esimeni sezimali zenkampani noma zomuntu onikezela ngefreyintshazi kusukela ngosuku lomsebenzi obheka amabhuku ezimali wokugcina, noma isitifiketi somcubunguli mabhuku noma isitifiketi esenziwa umhloli ofanayo wenkampani noma womuntu onikezela ngefreyintshazi, ukuthi inkampani noma umuntu onikezela ngefreyintshazi banezizathu ezikahle zokukholwa ukuthi izokwazi ukukhokha izikweletu zayo uma ngabe sekufanele zikhokhwe;
- (d) ukulinganisela okubhaliwe maqondana namazinga okuthengisa okunokwenzeka, imali engenayo, imali isiyonke noma inzuzo esele noma okunye ukuhlambekiselwa kwezezimali kwebhizinisi eliyifreyintshazi noma amafreyintshazi esimo esifanayo nemininingwane yokucabangela okwenzelwe phezu kwazo lezi zethulo.
- (2) Ikhasi ngalinye lombhalo wokudalula elishiwo esimisweni somthetho esincane (1) ngenhla kufanele sicaciswe maqondana nezitativende ezilapha.
- (3) Umbhalo wokudalula oshiwo esimisweni somthetho esincane (1) kufanele uphelekezelwe yisitifiketi esibhalwe ephepheni elinophawu lwenkampani evela kumuntu ofanelekile emthethweni ukuthi abhalise njengomuntu ophendulayo wenkampani yabantu abancane, noma umcwaningi wamabhuku enkampani, njengoba kungaba njalo, eqinisekisa ukuthi -
- (a) ibhizinisi lomuntu onikezela ngefreyintshazi liwukhathazeka okuhambayo;
- (b) ngokwazi kwakhe konke umuntu onikezela ngefreyintshazi uyakwazi ukuhlangabezana nezikweletu zamanje kanye nezincike egenjini;
- (c) umuntu onikezela ngefreyintshazi uyakwazi ukuhlangabezana nakho konke ukuzibophezela esikhathini sebhizinisi ezijwayelekile njengoba kufanele kukhokhwe konke; futhi
- (d) izitativende zezimali zonyaka ezicutshunguliwe zomuntu onikezela ngefreyintshazi zonyaka osandakuphela sezenziwe-
- (i) ngokuhambisana neNingizimu Afrika ngokwejwayelekile amazinga okuphendula;

- (ii) ngaphandle kwezinga elishiwo lapha, ngokwesisekelo sezinqubomgomoezihambelana neminyaka engaphambili;
 - (iii) ngokuhambisna nokuhlinzeka koMthetho Wezinkampani (Namba 61 ka-1973 noma nanoma yimuphi umthetho ongena esikhundleni salo Mthetho), kanye nayo yonke eminye imithetho esebebenzayo; kanye
 - (iv) kancane okukhombisa isimo sezimali, izindaba, imisebenzi kanye nemiphumela yomuntu onikezelala ngefreyintshazi ngalelo langa kanye nesikhathi abasishoyo.
- (4) Umbhalo odalulayo oshiwo esimisweni somthetho esincane (1) ngenhla kufanele uphelekezelwe -

 - (i) igama eyenza ibhizinisi ngaphansi kwalo;
 - (ii) igama lommeleli wayo;
 - (iii) ikheli layo lendawo; kanye
 - (iv) ne-e-meyili yalo kanye nenamba yocingo ehhovisi, kanye kanye nesitatimende esicacile sokuthi umuntu onikezelwe ifreyintshazi wesikhathi esizayo unelungelo lokuthinta nanoma yimuphi umuntu onikezelwe ifreyintshazi osohlwini, noma okukanye ukuvakashela nanoma yiziphi izitolo ezisetshenziswa umuntu onikezwie ifreyintshazi wamanje ukuhlola ulwazi oludalulwe ngumuntu onikezelala ifreyintshazi kanye namathuba efreyintshazi anikezwa yilo;


