

CIVIL AVIATION ACT, 2009 (ACT NO. 13 OF 2009)

CIVIL AVIATION REGULATIONS, 2011

The Minister of Transport intends, in terms of section 155(1) of the Civil Aviation Act, 2009 (Act No. 13 of 2009) and on the recommendation of the Civil Aviation Regulations Committee (CARCom), to amend the Civil Aviation Regulations, 2011 and the South African Civil Aviation Technical Standards, 2011 by the substitution/insertion of the following Parts:

PART 91 General operating and flight rules
PART 121: Air transport operations: Carriage on aeroplanes of more than 19 passengers or cargo
PART 135: Air transport operations: Small aeroplanes
SA-CATS 67 Medical certification
SA-CATS 91 General operating and flight rules
SA-CATS 135 Air transport operations: Small aeroplanes
