

Government Printing Works has implemented rules for completing and submitting the electronic Adobe Forms when you, the customer, submits your notice request.

Please take note of these guidelines when completing your form.

GPW Business Rules

1. No hand written notices will be accepted for processing, this includes Adobe forms which have been completed by hand.



- Notices can only be submitted in Adobe electronic form format to the email submission address <u>submit.egazette@gpw.gov.za</u>. This means that any notice submissions not on an Adobe electronic form that are submitted to this mailbox will be <u>rejected</u>. National or Provincial gazette notices, where the Z95 or Z95Prov must be an Adobe form but the notice content (body) will be an attachment.
- 3. Notices brought into GPW by "walk-in" customers on electronic media can only be submitted in Adobe electronic form format. This means that any notice submissions not on an Adobe electronic form that are submitted by the customer on electronic media will be <u>rejected</u>. National or Provincial gazette notices, where the Z95 or Z95Prov must be an Adobe form but the notice content (body) will be an attachment.
- 4. All customers who walk in to GPW that wish to submit a notice that is not on an electronic Adobe form will be routed to the Contact Centre where the customer will be taken through the completion of the form by a GPW representative. Where a customer walks into GPW with a stack of hard copy notices delivered by a messenger on behalf of a newspaper the messenger must be referred back to the sender as the submission does not adhere to the submission rules.
- 5. All notice submissions that do not comply with point 2 will be charged full price for the notice submission.
- 6. The current cut-off of all Gazette's remains unchanged for all channels. (Refer to the GPW website for submission deadlines <u>www.gpwonline.co.za</u>)
- 7. Incorrectly completed forms and notices submitted in the wrong format will be rejected to the customer to be corrected and resubmitted. Assistance will be available through the Contact Centre should help be required when completing the forms. (012-748 6200 or email <u>info.egazette@gpw.gov.za</u>)
- 8. All re-submissions by customers will be subject to the above cut-off times.
- 9. All submissions and re-submissions that miss the cut-off will be rejected to the customer to be submitted with a new publication date.
- 10. Information on forms will be taken as the primary source of the notice to be published. Any instructions that are on the email body or covering letter that contradicts the notice form content will be ignored.

You are therefore advised that effective from **Monday**, **18 May 2015** should you not comply with our new rules of engagement, all notice requests will be rejected by our new system.

CORRECTION

TO THE COMPULSORY SPECIFICATION FOR ENERGY EFFICIENCY AND LABELING OF ELECTRICAL AND ELECTRONIC APPARATUS (VC 9008)

I, Dr Rob Davies, Minister of Trade and Industry, hereby under Section 13(1) (a) of the National Regulator for Compulsory Specifications Act (Act 5 of 2008), make a correction to the current Compulsory Specification for Energy Efficiency and Labeling of Electrical and Electronic Apparatus (VC 9008), published by Government Notice R944 of 28 November 2014, as set out in the attached Schedule, with effect from the date of publication of this notice.

SCHEDULE CORRECTION NOTICE to the COMPULSORY SPECIFICATION FOR ENERGY EFFICIENCY AND LABELING OF ELECTRICAL AND ELECTRONIC APPARATUS (VC 9008) published by Government Notice R. 944 (Government Gazette No. 38232) of 28 November 2014

This notice hereby makes corrections to the above Compulsory Specification as follows:

This compulsory specification shall be effective in accordance with the following phases:

Delete:

"Phase 2:

- Nine (9) months after the publication of this notice for electric ovens, refrigerators, freezers, dishwashers, tumble dryers, washer-dryer combinations and washing machines.
- Products that are already in the market and approved by the NRCS for safety requirements are to comply with this compulsory specification twelve (12) months after the publication of this notice".

"Phase 3:

 Eighteen (18) months after the publication of this notice, for air conditioners and heat pumps."

and replace with:

"Phase 2:

- From 26 February 2016 for electric ovens, refrigerators, freezers, dishwashers, tumble dryers, washer-dryer combinations and washing machines.
- Products that are already in the market and approved by the NRCS for safety requirements are to comply with this compulsory specification from 26 May 2016".

"Phase 3:

From 28 November 2016 for air conditioners and heat pumps."
