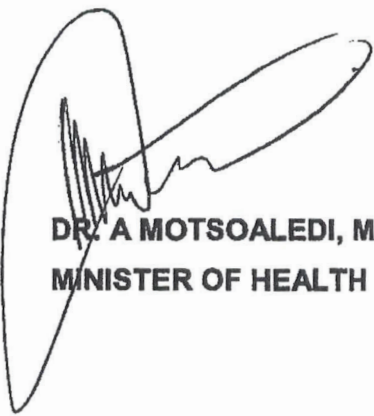
SCHEDULE

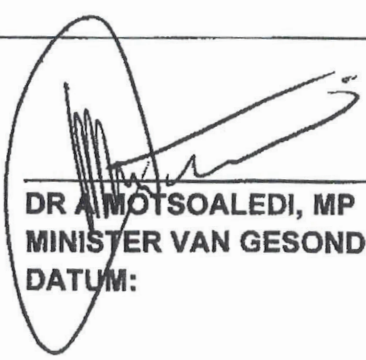
