I, Bomo Edna Edith Molewa, Minister of Environmental Affairs, hereby under section 24H of the National Environmental Management Act, 1998 (Act No. 107 of 1998) and Regulation 9 of the section 24H Registration Authority Regulations, 2016, published under Government Notice No. 849, Gazette No. 40154 on 22 July 2016, approve the levying of fees for application for registration, lodging of appeals and annual fees for registered candidate environmental assessment practitioners and registered environmental assessment practitioners, as set out in the Schedule hereto.

SCHEDULE

1. On 08 February 2018, in Government Notice No. 632 in Gazette No. 41434, I appointed the Environmental Assessment Practitioners Association of South Africa (EAPASA) in terms of section 24H(3)(a) and (6) of the National Environmental Management Act, 1998 (Act No. 107 of 1998) as the single registration authority for environmental assessment practitioners for a period of five years.
2. In terms of Regulation 9 of the Section 24H Registration Authority Regulations, 2016, the said Regulations come into effect on the date of the appointment of the first registration authority.
3. EAPASA has determined and recommended fees for application for registration, lodging of appeals and annual fees for registered candidate environmental assessment practitioners and registered environmental assessment practitioners.
4. These fees have been considered and the following fees are hereby approved to be levied by EAPASA:

Categories of professional fees for Environmental Assessment Practitioners (EAPs)	Fee
Registration assessment fee: EAP	R1 500,00
Registration assessment fee: Candidate EAP	R800,00
Annual subscription: EAP	R1 200,00
Annual subscription: Candidate EAP	R600,00
Appeal fee	R1 500,00
