SCHEDULE

Definition

1. In these regulations "the Regulations" means the Regulations published under Government Notice No. R. 1016 of 19 December 2014.

Amendments of Regulations

2. The Regulations are hereby amended by adding a new LRA Form 3.6A to give effect to the amendments to section 32 with the insertion of section 32A which deals with the renewal and extension of funding agreements.

Section 208 of the Labour Relations Act empowers the Minister to make regulations regulating any matter that may or must be prescribed.

The new LRA Form 3.6A is hereby introduced and published."
