DEPARTMENT OF JUSTICE AND CONSTITUTIONAL DEVELOPMENT**NO. R. 522****01 APRIL 2019****NOTICE OF TABLING IN PARLIAMENT OF AMENDMENTS TO THE LEGAL AID MANUAL**

1. Notice is hereby given in terms of section 24(2)(b) of the Legal Aid South Africa Act, 2014 (Act No. 39 of 2014) that the Minister of Justice and Correctional Services has tabled amendments to the Legal Aid Manual in Parliament.
2. In terms of section 24(3) of the Legal Aid South Africa Act, 2014, the amendments to the Legal Aid Manual take effect 60 days after publication of this notice.
3. Paragraph 4.5.3(a) the Legal Aid Manual is amended to provide as follows:
"Legal Aid SA will reimburse Judicare practitioners for the cost of travelling from their office to court, up to a maximum of 150km per return trip. No reimbursement for travel will be paid for the first 10km of any travel claim. Therefore the maximum kilometres that Legal Aid SA will pay for travel per return trip will be 140km."

1. Kennis word hiermee ingevolge artikel 24(2)(b) van die Wet op Regshulp Suid-Afrika, 2014 (Wet No. 39 van 2014) gegee dat die Minister van Justisie en Korrektiewe Dienste wysigings aan die Regshulphandleiding in die Parlement ter tafel gelê het.
2. Ingevolge artikel 24(3) van die Wet op Regshulp Suid-Afrika, 2014, tree die wysigings aan die Regshulphandleiding 60 dae na publikasie van hierdie kennisgewing in werking.
3. Paragraaf 4.5.3(a) van die Regshulphandleiding word as volg gewysig:
"Regshulp Suid-Afrika sal Judicare praktisyns vir die koste van reis vanaf hul kantoor na die hof vergoed, tot 'n maksimum van 150km per retoer rit. Geen vergoeding vir reis sal vir die eerste 10km van 'n rit eis betaal word nie. Derhalwe is die maksimum kilometers waarvoor Regshulp Suid-Afrika vir reis sal betaal 140km per retoer rit."
