ENFORCEMENT BY LOCAL AUTHORITY

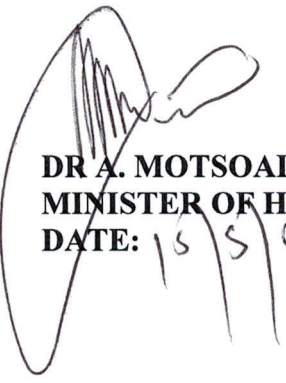
