Schedule 1:	Part 61	(Pilot Licensing)
Schedule 2:	Part 91	(General Aviation & Operating Flight Rules)
Schedule 3:	Part 93	(Corporate Operations)
Schedule 4:	Part 135	(Air Transport Operations – Carriage of less than 20 Passengers or Cargo)
Schedule 5:	Part 121	(Air Transport Operations – Carriage on Aeroplanes of more than 19 Passengers or Cargo)

The Director of Civil Aviation intends, in terms of section 163 of the Act and on Recommendation of CARCom, to amend the Technical Standards by the amendment of the following parts set out in the Schedules below:

Schedule 6: SA CATS 44 (Maintenance Rules – Non-type Certificated Aircraft)
