



REGULATIONS IN RESPECT OF THE SINGLE MAXIMUM NATIONAL RETAIL PRICE FOR ILLUMINATING PARAFFIN

- I, Mr. G. Mantashe, Minister of Mineral Resources and Energy, under section 2(1)(c) of the Petroleum Products Act, 1977 (Act No. 120 of 1977), determine that a maximum retail price for Illuminating Paraffin (excluding the price of any form of packaging) will become effective on the first Wednesday of every month.
- 2. The single maximum retail price for illuminating paraffin, excluding the price of any form of Packaging for the period 02 October 2019 to 05 November 2019 will be 1228.0 c/l.

3. Commencement

These regulations shall come into operation at 00:01 on 02 October 2019
