## PROCLAMATION NO. R. 52 OF 2019

**FINANCIAL AND FISCAL COMMISSION ACT, 1997: DETERMINATION OF  
REMUNERATION OF MEMBERS OF FINANCIAL AND FISCAL COMMISSION**

In terms of section 9(1) of the Financial and Fiscal Commission Act, 1997 (Act No. 99 of 1997), I hereby, with effect from one year before the date of publication of the proclamation, determine the following remuneration for the members of the Financial and Fiscal Commission:

- (a) Chairperson in a full-time capacity: R1 880 736 per annum;
- (b) Deputy Chairperson in a part-time capacity:
  - (i) R695 per hour for attending meetings;
  - (ii) R232 per hour for preparation for meeting; and
  - (iii) R232 per hour for travelling time; and
- (c) Other members in a part-time capacity:
  - (i) R572 per hour for attending meetings;
  - (ii) R191 per hour for preparation for meeting; and
  - (iii) R191 per hour for travelling time.

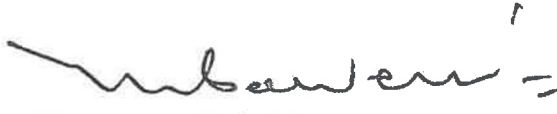
