**SCHEDULE****Definitions**

1. In these regulations, “**the regulations**” means regulations relating to the qualifications which entitles psychologists to registration published by Government Notice R554 in *Government Gazette* 22390 of 22 June 2001, any word or expression to which a meaning has been assigned in the regulations, shall have that meaning and unless the context otherwise indicates.

**Amendment of regulation 2 of the regulations.**

2. Regulation 2 of the regulations is hereby amended by –
- (a) the insertion, after the words “Counselling Psychology”, of the words “Neuropsychology”; and
  - (b) the addition of the following qualification:
