RETAIL PRICE FOR ILLUMINATING PARAFFIN**

1. I, Mr. G. Mantashe, Minister of Mineral Resources and Energy, under section 2(1)(c) of the Petroleum Products Act, 1977 (Act No. 120 of 1977), determine that a maximum retail price for Illuminating Paraffin (excluding the price of any form of packaging) will become effective on the first Wednesday of every month.
2. The single maximum retail price for illuminating paraffin, excluding the price of any form of Packaging for the period 04 December 2019 to 31 December 2019 will be 1173.0 c/l.
3. **Commencement**

These regulations shall come into operation at 00:01 on 04 December 2019
