

**NATIONAL ROAD TRAFFIC ACT, 1996 (ACT NO.93 OF 1996)
APPOINTMENT OF OFFICERS BY THE CHIEF EXECUTIVE OFFICER**

I, **Fikile April Mbalula**, the Minister of Transport, hereby in terms of Section 93A(a) of the National Road Traffic Act, 1996 (Act No.93 of 1996), give notice, that the Chief Executive Officer may upon such conditions as he or she may determine, appoint as many persons as inspectors of licences, examiners of vehicles, examiners for driving licences, traffic officers and traffic wardens, as he or she may deem expedient as provided for in section 3A(1) (a) of Act 1996 (Act No. 93 of 1996), this shall be so regulated from the date of publication of this Notice in the Gazette, in accordance with provisions of that section.

The Notice published in Government Gazette 34316, GNR.310 of 25 May 2011 is hereby withdrawn.



AMENDMENT OF THE NATIONAL ROAD TRAFFIC REGULATIONS

I, Fikile April Mbalula, the Minister of Transport, makes the regulations in the Schedule hereto under section 75 of the National Road Traffic Act, 1996 (Act No.93 of 1996).

SCHEDULE

Definition
