

HIGH COMMISSIONER'S NOTICE No. 9 OF 1919.

It is hereby notified for general information that, in terms of the Regulations made under section *two* of the Swaziland Diseases of Stock Proclamation, 1918, His Excellency the High Commissioner has been pleased to declare the areas in Swaziland mentioned in the schedule annexed hereto to be infected areas on account of East Coast fever.

SCHEDULE.

1. That portion of Native Area 6 Peak District, bounded by Right-of-Way 9, the Black Mbuluzi River and the Nsagana and Mbobour Streams.
2. Area west of Mbabane in the Mbabane District, bounded by the Transvaal border on the west, Right-of-Way 1 on the north-east, Right-of-Way 12 on the east, and Right-of-Way 4 on the south and south-west.

Note by the Resident Commissioner of Swaziland.

The whole of Swaziland had been declared an infected area until the recent promulgation of new regulations under the Swaziland Diseases of Stock Proclamation, 1918. The two small areas notified above are now the only infected areas in Swaziland. The outbreaks are not recent, and no deaths of cattle from East Coast fever disease have occurred in the territory since May, 1918.
