That whereas JOSEFA MOFOLO, of Teyateyaneng, Basutoland, did on the 20th day of November, 1918, petition the Court of the Resident Commissioner of Basutoland for leave to sue by Edict his wife, ADELE, lately of Basutoland, but last heard of at Johannesburg, Transvaal, for restitution of conjugal rights; and, on failure thereof, for a decree of divorce by reason of her malicious desertion and for custody of the minor child;

Now this Court having taken the prayer of the said JOSEFA MOFOLO into consideration, and granted the same accordingly, by these presents doth summon the said ADELE, lately of Teyateyaneng, to appear before the said Court of the Resident Commissioner of Basutoland at Teyateyaneng on the third day of March, 1919, at 10 o'clock in the forenoon, either in person or by proxy, to show cause (if any) why she shall not be ordered to return to, and live and cohabit with, the applicant as her husband; or otherwise, why a decree of divorce shall not be granted by reason of her wilful and malicious desertion of him; and why he shall not have custody of the minor child of the said marriage.
