### LOST TITLE-DEED, SWAZILAND CONCESSION.

Notice is hereby given that I intend applying on behalf of the Swaziland Administration for a certified copy of Cession No. 51/1897 dated 6th May, 1897, and registered 30th July, 1897, whereunder Theophilus Shepstone ceded in favour of the late Government of the South African Republic certain portion of Land Concession No. 75 L (formerly No. 81) granted by Umbandine, then King of the Swazi Nation, in favour of Albert Bremer on the 27th June, 1888, confirming a verbal grant of 25th January, 1887.

And all persons having objection to the issue of such copy are hereby requested to lodge the same in writing with the Registrar of Deeds for Swaziland at Pretoria within three months from the date of the first publication of this notice.
