

PROCLAMATION

By HIS EXCELLENCY THE HIGH COMMISSIONER.

Whereas it is desirable to make further provision out of the public revenue or other funds of the Bechuanaland Protectorate to meet certain additional expenditure incurred during the year which ended the 31st day of March, 1918;

Now therefore under and by virtue of the powers in me vested I do hereby declare proclaim and make known as follows:—

1. The public revenue or other funds of the Bechuanaland Protectorate are hereby charged with a further sum of £3299. 2s. 9d. (three thousand two hundred and ninety-nine pounds two shillings and nine pence) to meet expenditure incurred during the year which ended the 31st day of March, 1918, in excess of the amounts appropriated for that purpose according to the particulars set forth in the schedule to this Proclamation.

2. This Proclamation may be cited as the Bechuanaland Protectorate Further Appropriation (1917-18) Proclamation 1919 and shall have force and take effect from the date of its publication in the *Gazette*.

NOTE (3).—It is not unusual for firms in Holland and the Netherland East Indies to be registered under names commencing with descriptive terms such as "Handel Maatschappy" (Trading Company) or "Naamlooze Venootschap" (Limited Liability Company). In such cases it has been found more convenient to publish the firm under its proper name, followed by the general descriptive term "Handel Maatschappy" or "Naamlooze Venootschap" (N.V.) as in the case of an English company. For instance, Handel Maatschappy van den Berg & Company and Naamlooze Venootschap de Kommeet v/a Dumonceau Frères, will be found under "Berg" and "Kommeet" respectively, and not under "Handel" or "Naamlooze."
