HIGH COMMISSIONER'S NOTICE No. 83 of 1919.

It is hereby notified for general information that His Excellency the High Commissioner, acting under the powers conferred by section ten of Proclamation No. 71 of 1914, and all other powers enabling him thereunto, has been pleased, on behalf of His Majesty to give and grant licence to all persons residing, carrying on business, or being in the Territory of Southern Rhodesia, to purchase, import, and deal in goods that are owned by persons or bodies of persons resident or carrying on business in Germany, and that are or were at the outbreak of war on board of enemy vessels that have been handed over to the Allied or Associated Governments: Provided always that a permit be first obtained from the Custodian of Enemy Property in respect of any such transaction: and provided further that payment for such goods is to be made to the Custodian of Enemy Property or to any officer designated by His Majesty's Government for receiving payment in respect of similar transactions entered into by persons residing, carrying on business, or being in the United Kingdom.
