# PROCLAMATION

BY HIS EXCELLENCY THE HIGH COMMISSIONER.

Whereas it is desirable to authorize the Administrator to control and restrict or prohibit the export of gold and silver from the territory of Southern Rhodesia (herein after called "the Territory") and to prevent the misuse of gold or silver coin in the Territory

the Territory;
Now therefore under and by virtue of the powers in me vested I do hereby declare proclaim and make known as follows:—

1. It shall be lawful for the Administrator by notice in the Gazette to make regulations

(i) controlling and restricting or prohibiting the export of gold and silver whether in the form of coin or in the form of bullion or jewellery or ornaments to such destinations as may be prescribed therein;

(ii) prohibiting

(a) the melting down or breaking up of current gold or silver coin or the using of such coin otherwise than as

(b) the hoarding of British gold or silver coin; and (c) the buying or selling of current British gold or silver coin at above its face value.

2. Such regulations may prescribe penalties for any contravention thereof not exceeding a fine of five hundred pounds and in default of payment imprisonment with or without hard labour for a period not exceeding one year or such imprisonment without the option of a fine or both such fine and such imprisonment.

3. In this Proclamation and in any regulations made thereunder "British gold or silver coin" shall include any gold or
silver coin lawfully current in any part of His Majesty's
Dominions and "current gold or silver coin" shall include any
gold or silver coin lawfully current in any country.

4. This Proclamation shall have force and take effect from the
date of its publication in the Gasette.
