#### PROCLAMATION

BY HIS ROYAL HIGHNESS THE HIGH COMMISSIONER.

Whereas it is desirable to make provision out of the public revenue or other funds of Basutoland for the service of the year ending the 31st day of March, 1922;

Now therefore, under and by virtue of the powers in me vested I do hereby declare, proclaim and make known as follows:—

- 1. The public revenue or other funds of Basutoland are hereby charged towards the service of the year ending the 31st day of March, 1922, with a sum of £256,120 (Two hundred and Fifty-six thousnad, One hundred and twenty pounds).
- 2. The moneys granted by this Proclamation shall be applied to the purposes and services set forth in Schedule annexed hereto and more particularly specified in the Estimates of Expenditure of Basutoland for the year ending the 31st day of March, 1922, submitted to and approved by the Secretary of State for the Colonies
- 3. The moneys granted by this Proclamation shall not be issued or applied to any use, intent or purpose other than the particular services to which the said amounts have been granted respectively by this Proclamation.
- 4. This Proclamation may be cited as the Basutoland Appropriation Proclamation 1921 and shall have force and take effect from the first day of April 1921.

### PROCLAMATION

By His Royal Highness the High Commissioner.

Whereas it is desirable to amend in certain respects the Basutoland Trading Proclamation No. 30 of 1918 (herein after referred to as the "said Proclamation");

Now therefore under and by virtue of the powers in me vested, I do hereby declare proclaim and make known as follows:—

1. Sub-section (1) of section three of the said Proclamation shall be and is hereby repealed and the following sub-section substituted therefor:—

"(1) A Licensing Proclamation of the said Proclamation of the said Proclamation substituted therefor:—

"(1) A Licensing Board shall be constituted for the consideration and determination subject to the provisions of this Proclamation of all applications for the grant of general traders' licences and of all applications for the renewal or transfer of general traders' licences which may be referred to the Board under section six of this Proclamation. Such Board shall consist of three persons in the service of the Basutoland Government, viz.,

"(a) two persons who shall be appointed annually by the High Commissioner by notice in the Gazette and who shall hold office until the thirty-first day of December in the year in which they are appointed;

"(b) the Assistant Commissioner of the district in respect of which the grant or, in the case of applications referred to the Board in terms of section six of this Proclamation, the transfer or renewal of the licence is applied for."

2. Section six of the said Proclamation shall be and is hereby

2. Section six of the said Proclamation shall be and is hereby repealed and the following substituted therefor:—

"General traders' licences issued in terms of this Proclamation may be transferred or renewed by the Assistant Commissioner of the district in respect of which the licence has been issued. Provided that the Assistant Commissioner to whom application for such transfer or renewal has been made may in his discretion and shall, if so instructed by the Resident Commissioner, refer any such application for transfer or renewal to the Licensing Board constituted under section three hereof, and it shall thereupon be competent for such Board to consider and determine whether and under what conditions, if any, such licence may be transferred or renewed." renewed.

3. Sub-section (1) of section twelve of the said Proclamation shall be and is hereby amended by the deletion of the last sentence thereof and the substitution therefor of the following:—

"For the transfer of a general trader's licence the sum of one-quarter per centum upon the whole purchase consideration paid by the transferee provided however that such transferee shall be entitled to an abatement in respect of such portion of the purchase price which he may prove to the satisfaction of the Resident Commissioner or Assistant Commissioner as the case may be represents the value of stock-in-trade or other merchandise included in the transfer.

"For the purpose of assessing the above duty the officer to whom the payment is to be made may require sworn declarations by the transferor and transferee showing the amount of the total purchase consideration and any sums in respect of which an abatement is claimed.

"Provided further that no transfer duty shall be payable in cases where no change of beneficial interest is effected."

For the transfer of a commercial traveller's licence a sum of one pound, and for the transfer of a miller's licence a sum of one pound, and for the transfer of a miller's licence a sum of ten shillings shall be paid."

4. (1) The following additional annual licences, to be known as "Miscellaneous Licences" shall be and are hereby imposed with effect as on and from the 1st day of July, 1921:—

Provided that where any such licence is taken out after the thirtieth day of June in any year only one-half of the full rate shall be charged, and provided further that such licences shall not be imposed in respect of persons carrying on the several businesses herein detailed in any area outside those generally known as Government Reserves.

- (2) The sum to be charged for the transfer of any such licence shall be ten shillings.
- (3) Save as is in this section otherwise provided such licences and the persons carrying on the several businesses herein detailed shall be subject to the provisions of the said Proclamation in so far as they relate to licences for commercial travellers, hawkers, and travelling traders.
- 5. Section thirteen of the said Proclamation shall be and is hereby amended by the addition of the following sub-section:—

"(3) the provisions of this section shall mutatis mutandis apply to cases where transfer of a licence is refused."

- 6. Sub-section (1) of section two of the said Proclamation shall be and is hereby amended by the insertion therein after the words "travelling trader" of the following words "or the holder of a miscellaneous licence in terms of section four of the Basutoland Trading Amendment Proclamation 1921."
- 7. Sections fourteen and fifteen of the said Proclamation shall be and are hereby amended by the insertion therein after the words "travelling trader" of the following words "or carrying of any of the trades or callings specified in section four of the Basutoland Trading Amendment Proclamation, 1921."
- 8. This Proclamation may be cited for all purposes as the Basutoland Trading Amendment Proclamation 1921 and save as in section four hereof otherwise provided shall have force and take effect from the date of its publication in the Gazette.
