PROCLAMATION

By His ROYAL HIGHNESS THE HIGH COMMISSIONER.

Whereas it is expedient to amend the Native Labour Regulation (Swaziland) Proclamation 1913 (herein after referred to as "the said Proclamation");
Now therefore under and by virtue of the powers authorities

and jurisdiction conferred upon and committed to me by His Majesty under the Swaziland Order-in-Council 1903 as amended by the Swaziland Order-in-Council 1906 and the Swaziland Order-in-Council 1909 I do hereby declare proclaim and make known as follows:

1. No labour agent or runner holding a licence or permit under the said Proclamation shall recruit in Swaziland any native who is ordinarily domiciled in Northern or Southern Rhodesia or in

Portuguese territory.

2. This Proclamation shall be read as one with the said Proclamation, and shall have force and take effect from the date of its publication in the Gazette.
