PROCLAMATION

By His Royal Highness the High Commissioner.

Whereas it is expedient to amend the provisions of Proclamation No. 2B of 1884 dated the 29th day of May 1884 (herein after referred to as "the said Proclamation") relating to appeals from decisions of Native Chiefs in Basutoland;

Now therefore under and by virtue of the powers in me vested I do hereby declare proclaim and make known as follows:

1. Regulation No. eight (which relates to appeals from decisions of Native Chiefs in Basutoland contained in the said Proclamation shall be and is hereby amended by the deletion therefrom of the words "exercising jurisdiction under the provisions of section 4 of these regulations."

2. This Proclamation shall have force and take effect from the date of its publication in the *Gazette*.

PROCLAMATION

By His Royal Highness the High Commissioner.

Whereas it is expedient further to amend the Large Game Preservation Proclamation, 1904, by providing for the temporary modification in particular portions of the Bechuanaland Protectorate of the definition of "large game" therein contained;

Now therefore under and by virtue of the powers in me vested I do hereby declare proclaim and make known as follows:—

1. Section two of the Large Game Preservation Proclamation, 1904, shall be and is hereby amended by the addition of the following proviso at the end thereof:—

"Provided however that it shall be lawful for the High Commissioner from time to time by notice in the *Gazette* to modify temporarily in respect of any specified portion of the Bechuanaland Protectorate the definition of 'large game' herein contained by excluding therefrom wildebeeste or any other animal, and the provisions of this Proclamation and of any Proclamation amending the same shall for the period specified in such notice cease in accordance therewith to apply in such portion to any animal excluded thereby."

2. This Proclamation shall have force and take effect from the date of its publication in the *Gazette*.

PROCLAMATION

By His Royal Highness the High Commissioner.

Whereas it is expedient to proclaim a certain portion of land in Swaziland to be Crown land;

Now therefore under and by virtue of the powers, authorities and jurisdiction conferred upon and committed to me by His Majesty under the Swaziland Order-in-Council 1903 and the Swaziland Order-in-Council 1906 and the Swaziland Order-in-Council 1909 and by virtue of the further authority conferred upon me under the Swaziland Crown Lands and Minerals Order-in-Council 1908, as amended by the Swaziland Crown Lands and Minerals Amendment Order-in-Council 1910, I do hereby declare, proclaim and make known as follows:—

The area of land in Swaziland described in the Schedule to this Proclamation shall from the date of the publication of this Proclamation in the *Gazette* be Crown land, and shall be registered and known as Lot No. 198, District Mbabane, Swaziland; provided always that the proclamation of the said area as Crown Land shall not affect any concession lease servitude or other right subsisting in respect of the said area which is registered at the date of such publication and is not vested in the Crown.
