Whereas it is expedient to make provision for the holding of the second term of the Special Court of Swaziland for 1923 in December instead of October or November, as provided by law;

Now therefore under and by virtue of the powers authorities and jurisdiction conferred upon and committed to me under the Swaziland Order-in-Council 1903 as amended by the Swaziland Order-in-Council 1906 and the Swaziland Order-in-Council 1909 I do hereby declare proclaim and make known as follows:

1. Notwithstanding the provisions of sub-section (9) of section fifteen of the Swaziland Administration Proclamation 1907 as amended, it shall be lawful for the High Commissioner to fix by notice in the Gazette a day in December 1923 for the commencement of the second term in 1923 of the Special Court of Swaziland, such term to extend until the business of the said Court shall have been completed.

2. This Proclamation may be cited for all purposes as the Swaziland Special Court (Postponement of Sitting, 1923) Proclamation 1923 and shall have force and take effect from the date of its publication in the Gazette.

PROCLAMATION

By His ROYAL HIGHNESS THE HIGH COMMISSIONER.

Whereas it is desirable to amend the Basutoland Medical Dental and Pharmacy Proclamation 1921 (herein after called "the Principal Law");

Now therefore under and by virtue of the powers in me vested I do hereby declare proclaim and make known as follows:—

1. Section one of the Principal Law is hereby amended by the addition of the following:— if "Practise" shall mean and include the doing or performing, whether for gain or otherwise, of any of such acts as specially belong to the calling of a medical practitioner, dentist or chemist respectively.

2. This Proclamation may be cited as the Basutoland Medical Dental and Pharmacy Proclamation 1921 (Amendment) Proclamation 1923 and shall have force and take effect from the date of its publication in the Gazette.

PROCLAMATION

By His Royal Highness the High Commissioner.

Whereas it is expedient to provide for the appointment of an Assistant Resident Commissioner in the Bechuanaland Protec-

Assistant Resident Commissioner in the Bechuanaland Protectorate:

Now therefore under and by virtue of the powers in me vested I do hereby declare proclaim and make known as follows:—

1. The High Commissioner may from time to time appoint an Assistant Resident Commissioner in the Bechuanaland Protectorate who shall be Chief Magistrate for the Bechuanaland Protectorate and as such shall have and may exercise throughout the Bechuanaland Protectorate all the powers jurisdiction and authority which have been or may hereafter be by law conferred upon an Assistant Commissioner or Resident Magistrate.

2. The Assistant Resident Commissioner, in addition to the powers conferred upon him by the preceding section, shall have power to deal with such cases, civil or criminal, as the Resident Commissioner may by written instructions given from time to time either generally as to any class of case or specially as to individual cases assign to him for disposal, and in respect of any case or class of cases so assigned the Assistant Resident Commissioner shall have the same powers as have been or may hereafter be by law conferred upon the Resident Commissioner.

3. This Proclamation shall have force and effect from the twelfth day of November, 1923.

Whereas it is expedient to cancel in part certain right-of-way in the Mankaiana District, formerly known as the Mbabane (South) Mankaiana District, awarded by the Special Commissioner under section two of Proclamation No. 13 of 1909;

Now therefore under and by virtue of the powers authorities and jurisdiction conferred upon and committed to me by His Majesty under the Swaziland Order-in-Council 1903 as amended by the Swaziland Order-in-Council 1906 and the Swaziland Order-in-Council 1909, I do hereby declare proclaim and make known as follows:—

1. The award of portion of the Mankaiana-Mbabane right-of-way branch road No. 1, crossing (a) farm No. 141 (formerly portion of U.44 in Concession 20 L) and (b) the portion of U.44 within the remaining extent of Concession 20 L deviating about one mile south-east of the north-west corner beacon of farm No. 141 crossing the source of the Mtimane stream and rejoining right-of-way No. 1 at a point about one mile east of the north-west corner beacon of the remaining extent of Concession 20 L, described in the Special Commissioner's Report dated the 5th December 1908, which took effect under and by virtue of Proclamation No. 21 of 1909 on the 1st January 1910 shall be and is hereby cancelled.

2. This Proclamation shall have force and take effect from the date of its publication in the Gazette.
