### EXTRADITION OF FUGITIVE OFFENDERS FROM NORTHERN RHODESIA TO SOUTH-WEST AFRICA.

Under the provisions of sub-section (4) of section three of the Fugitive Criminals (Further Provision) Act, 1926, I do hereby proclaim, declare and make known that there is in force in the territory of Northern Rhodesia a law under which any person who is alleged to have committed an offence in the mandated territory of South-West Africa and is found in the territory of Northern Rhodesia may be removed therefrom in custody and under warrant for the purpose of his being sent to the said mandated territory there to be dealt with in accordance with law.
