PROCLAMATION

BY HIS EXCELLENCY THE HIGH COMMISSIONER.

Whereas it is expedient further to amend the Swaziland Pensions Proclamation No. 34 of 1924 (herein after referred to as the said Proclamation) so as to provide for the receipt of pensions by the holders of certain offices in the Government of Swaziland not included in the Second Schedule to the said Proclamation:

Now therefore under and by virtue of the powers, authorities and jurisdiction conferred upon and committed to me under the Swaziland Order-in-Council 1903 as amended by the Swaziland Order-in-Council 1906 and the Swaziland Order-in-Council 1909, I do hereby declare proclaim and make known as follows:—

1. The Second Schedule to the said Proclamation shall be and is hereby amended by the addition at the end thereof of the following:—

"Stock inspectors employed by the Swaziland Government

"Stock inspectors employed by the Swaziland Government whose appointment as such has been or shall hereafter be notified in the Gazette."

2. This Proclamation shall be read as one with the said Proclamation as amended by High Commissioner's Proclamations No. 54 of 1924, No. 13 of 1926 and No. 28 of 1926 and the amendments hereby made shall be deemed to have been inserted in the said Proclamation at the date of the taking effect thereof and to have had effect from such date.

PROCLAMATION

BY HIS EXCELLENCY THE HIGH COMMISSIONER.

Whereas it is desirable to make further provision out of the public revenue and other funds of Basutoland to meet certain additional expenditure incurred during the year which ended the 31st day of March, 1926;

Now therefore under and by virtue of the powers in me vested 1 do hereby declare, proclaim and make known as follows:—

1. The public revenue or other funds of Basutoland are hereby charged with a further sum of £11,698. 16s. 2d. (Eleven thousand, Six hundred and Ninety-eight pounds Sixteen shillings and Two-pence) to meet expenditure incurred during the year ended the 31st day of March, 1926, in excess of the amounts appropriated for that purpose according to the particulars set forth in the Schedule to this Proclamation.

2. This Proclamation may be cited as the Basutoland Further Appropriation (1925-26) Proclamation, 1927, and shall have force and take effect from the date of its publication in the Gazette.
