By MAJOR-GENERAL HIS EXCELLENCY THE RIGHT HONOURABLE THE EARL OF ATHLONE, KNIGHT GRAND CROSS OF THE MOST HONOURABLE ORDER OF THE BATH, KNIGHT GRAND CROSS OF THE MOST DISTINGUISHED ORDER OF ST. MICHAEL AND ST. GEORGE, KNIGHT GRAND CROSS OF THE ROYAL VICTORIAN ORDER, COMPANION OF THE DISTINGUISHED SERVICE ORDER, PERSONAL AIDE-DE-CAMP TO HIS MAJESTY THE KING, HIGH COMMISSIONER FOR SOUTH AFRICA, AND GOVERNOR-GENERAL AND COMMANDER-IN-CHIEF IN AND OVER THE UNION OF SOUTH AFRICA.

Whereas by Proclamations Nos. 40 of 1927 and 46 of 1927 dated 15th February, 1927, and 18th February, 1927, respectively, certain portions of the farm Grasfontein No. 240, District Lichtenburg Mining District of Klerksdorp, Transvaal Province, were proclaimed alluvial diggings for precious stones.

And whereas it is desirable to withdraw the said portions of the said farm Grasfontein No. 240, from the operation of the said proclamations;

Now therefore under and by virtue of the powers in me vested I do hereby declare, proclaim and make known that the said portions of the said farm Grasfontein No. 240, are hereby withdrawn from the operation of the said proclamations as from the 25th day of February, 1927.

Whereas it has been shown to my satisfaction that there are reasonable prospects for believing that precious stones exist in payable quantities on portions "A," "B," "C," "D," portions 1, 2 and remaining extent of portion "E," portion "F," portions 1, 2 and remaining extent of portion "G," portion "H," portions 1, 2 and remaining extent of portion "J," portions 1, 2 and remaining extent of portion "K," portions 1, 2, 3 and 4 of portion "L," portions 1, 2, 3 and 4 and remaining extent of portion "M," and portion "N," of the farm Grasfontein No. 240, District Lichtenburg, Mining District of Klerksdorp, Transvaal Province, in extent and registered as shown in the attached schedule.

And whereas by proclamation dated the 15th day of February, 1927, portions "A" to "H" of the said farm as above described and by proclamation dated the 18th day of February, 1927, portions "J" to "N" of the said farm as above described were proclaimed as public diggings on the 25th day of February, 1927.

GOVERNMENT NOTICE.

[Date 1st March, 1927.

Notice is hereby given that His Excellency the Governor-General under the powers vested in him by sub-section (1) of Section twenty-three of the Precious Stones (Alluvial) Amendment Act, 1919, has been pleased to amend the regulation promulgated under paragraph (3) of Government Notice No. 890 dated 27th May, 1925, as amended by Government Notices No. 881 dated 28th May, 1926, and 1322 dated 28th July, 1926, by the deletion of paragraph (d) and the substitution therefor of the following new paragraphs (d) and (e) :—

- (d) No person shall peg any claim on land which has been proclaimed an alluvial digging before the Mining Commissioner or some other person authorised in that behalf has publicly read out the proclamation proclaiming such digging and has given notice by signal that the land proclaimed is available for the pegging of claims.
- (e) Any person contravening or failing to comply with this regulation or failing to carry out any order given by the Mining Commissioner or any of his assistants or any police officer for the more effective carrying out of this regulation shall be guilty of an offence, and liable on conviction to a fine not exceeding £50 (fifty pounds) and any claims pegged in contravention of these regulations shall be null and void.

GOEWERMENTS KENNISGEWING.

Kennisgewing geskied hiermee dat dit Sy Eksellensie die Goewerneur-Generaal behaag het, kragtens die magte hom verleen onder Sub-Artikel (1) van Afdeling drie-en-twintig van die Edelgesteentes (Alluviaal) Wysingswet 1919, om die regulasie afgekondig onder paragraaf (3) van Goewermmentskennisgewing No. 890 van 27 Mei, 1925, soos gewysig deur Goewermmentskennisgewings Nos. 881 van 28 Mei, 1926 en 1322 van 28 Julie, 1926, te wysig deur die uitkrapping van paragraaf (d) en die vervanging daarvoor van die volgende nuwe paragrawe (d) en (e) :—

- (d) Geen persoon mag enige kleim afpen op grond wat geproklameer is as 'n publieke delwerpe totdat die Mynkommissaris, of 'n ander persoon daartoe gemagtig, in die openbaar die proklamasie afgelees het sulke delwerpe proklamerende en deur 'n teken te kenne gegee het dat die geproklameerde grond beskikbaar is vir die afpenning van kleims.
- (e) Enige persoon wat hierdie regulasie oortree of wat in gebreke bly om enige bevel uit te voer wat deur die Mynkommissaris of enige van sy assistente, of deur enige polisieagent gegee word vir die meer doeltreffende uitvoering van hierdie regulasie, sal skuldig wees aan 'n oortreding en by skuldigbevinding strafbaar wees met 'n boete van nie te bowegaande £50 (vyftig pond) en enige kleims wat afgepen is in oortreding van hierdie regulasies sal van nul en gener waarde wees.
