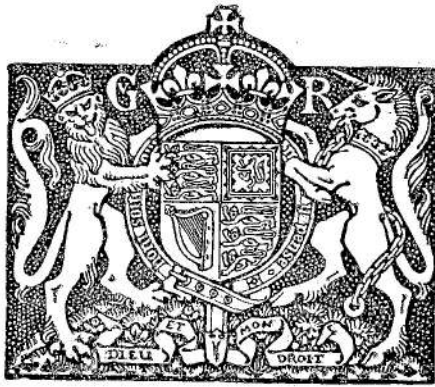

PROCLAMATION

BY HIS EXCELLENCY THE HIGH COMMISSIONER.

Whereas it is desirable to amend the Bechuanaland Protectorate Herbage Preservation (Further Provision) Proclamation No. 27 of 1927 (hereinafter referred to as "the principal law"):

Now therefore under and by virtue of the powers in me vested I do hereby declare, proclaim and make known as follows:

1. Section one of the principal law shall be and is hereby amended by the deletion of the words "section six" and the substitution therefor of the words "section five."

2. This Proclamation shall be read as one with the principal law and shall have force and take effect from the date of its publication in the *Gazette*.
