## HIGH COMMISSIONER'S NOTICE No. 75 of 1933.

It is hereby notified for general information that, under the powers in him vested by section *twenty-seven* of the Native Labour Regulation (Swaziland) Proclamation, 1913, His Excellency the High Commissioner has been pleased to repeal Regulation No. 17 of the Regulations published under High Commissioner's Notice No. 53 of 1913 and to substitute the following:

17. It shall not be lawful for any person recruiting native labourers under the Proclamation to make any advance to any native in excess of the sum or value of five pounds exclusive of any fines imposed by a competent court or taxes but inclusive of the reasonable cost of food *en route* to the place of employment pass fees or charges for railway and motor services transport and no interest shall be chargeable on any such advance. An employer shall, for the purpose of this regulation be deemed to have recruited native labourers under the Proclamation if he shall have entered into an attested contract with such natives.
